This illness is found throughout the world and is known to infect a high percentage of dogs at least once during their lifetime. There are many strains of Bordetella. Dogs are particularly susceptible when under any kine of stress, like being away from family while being boarded at veterinarian offices, day care facilities, and kennels. Thus the name "Kennel Cough". Vaccines offered by vets cover most but not all strains of Bordetella.
