After your application is sent in we will review your packet and will notify you of acceptance status. Then there will be documents to fill out in regards to payment.

Tuition

Applicants must have intermediate riding skills, enthusiasm, eagerness and an open-minded curiosity towards learning.

Tuition is \$1000.00 per month with a 3 month minimum commitment. Tuition includes living accommodations. Payment is due in advance for each 3 month increment. Tuition is non-refundable.

Applicants must have current health insurance. Applicants must ride with a certified protective helmet and riding boots and/ or paddock boots and half chaps at all times.

2. Acknowledge that horseback riding is a dangerous activity and involves risks that may cause serious injury and in some cases death, because of the unpredictable nature and irrational behavior of horses, regardless of their training and past performance.

3. Voluntarily assume the risk and danger of injury or death inherent in the use of horse, equipment and gear provided to me by stable.

4. I clearly understand the following:

Horse riding or horse-drawn activity involves specific risks of property damage or personal injury to me or my minor children arising from approaching, handling, mounting, riding and dismounting the horse or horse-drawn vehicle, and from observing or participating in this activity, but that I nevertheless intentionally agree to assume these risks.

Upon mounting, and taking up the reins I am in primary control of the horse I am riding and the stable is not responsible for the results of my action or inaction;

I further know that horses are <u>not completely predictable</u>, and any horse can on occasion become frightened or upset, so as to rear up and run away;

Clearly understanding the above, and the fairness and meaning of this Agreement, and that I acknowledge that I have been given the opportunity to ask any questions concerning this matter;

I Hereby:

Release, discharge, and promise not to sue the stable, doing business under its own name or any other name and/or any of its owners, officers, employees and agents (hereinafter the "Releases"), for any loss, liability, damage, or cost whatsoever, arising out of or related to any loss, damage, or injury (including death) to my person or property.

Release the Releases from any claim that such Releases are or may be negligent in connection with my riding experience or ability including but not limited to training or selecting horses, maintenance, care, fit or adjustments of saddles or bridles, instruction on riding skills or leading and supervising riders.

Indemnify, and save and hold harmless the stable and its employees and agents from any against any loss, liability, damage or cost they may incur arising out of or in any way connected with either my use of the horse and any equipment or gear provided therewith or any acts or omissions of its employees or agents.

Agree to abide by and follow any instructions given or rules established by the stable or any of its employees, or agents with regard to my use of the horse or any equipment or gear provided.

Expressly agree that the foregoing release and wavier of liability, assumption of risk, and indemnity agreement is governed by the State of Arizona and is intended to be as broad and inclusive as is permitted by Arizona law, and that in the event any portion of this agreement is determined to invalid, illegal or unenforceable, the validity, legality and enforceability of the balance of the agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.

Acknowledge that this document is a contract and agree if a lawsuit is filed against the stable or its owners, agents, employees, for any injury or damage in breach of this contract, the Undersigned will pay all attorneys' fees and costs incurred by the stable in defending such an action.
