A local law Amending the Flood Damage Prevention Local Law in the Town of Hampton

Be it enacted by the Town Board of the

Section 3.2 of the Flood Damage Prevention Local Law be and hereby is amended to read as follows:

3.2 BASIS FOR ESTABLISHING THE AREAS OF SPECIAL FLOOD HAZARD

The areas of special flood hazard have been identified by the Federal Emergency Management Agency on Flood Insurance Rate Maps enumerated on Map Index No. 361442A 01-02 dated April 17, 1985.

The above documents are, hereby, adopted and declared to be a part of this local law and are filed at the Town of Hampton Clerk's Office.

This amendment shall take effect immediately.

Be it enacted this 14th day of September, 1989 by the Town Board of the Town of Hampton, Washington County, New York, to be effective immediately
