Any property that remains after the advertised pick up dates will be assessed late fees at the rate of \$50 per week. To protect the security of other property stored by County, Owner shall not have access to the property during the term of storage except by permission and as Owner shall be accompanied by an authorized agent or employee of County. Owner shall not perform any mechanical or maintenance work on Owner's property while in storage.
- 8. For boat storage, Owner is advised to remove from the boat prior to storage all loose equipment and property such as boat gear, which is stored at Owner's sole risk.
