- No other major crimes in our area
- Typically there isn't a quick response to noise violations due to lack officers and these complaints not considered a priority; therefore causing a delay before an officer arrives
- Barking dog complaints should be reported to animal control
- A traffic unit has been assigned for speeding issues on crested point and drag racing down eagle. The officer will be a the school crossing but they are trying to find another officer willing to monitor this location for nights and weekends
- CSPD is in the process of creating an app to upload ring videos to help capture crimes, especially theft. The app would allow you to upload video and submit a complaint
