**DATE:** Saturday, May 27, 2023

**TIME:** 6:00 a.m. – 11:00 a.m. **ALL PARTICIPANTS MUST CHECK-IN AT THE MCKENZIE PAVILION 6:00-7:30 PM on Friday, May 26th BEFORE PARTICIPATING. After Check-In, participants may begin at 6:00 a.m. Saturday from any location on the lake.**  
**Lunch will be served at 11:30 a.m. Final fish must be weighed at 11:00 a.m.**

**ENTRY FEE:** \$65.00 per boat (2 person team), includes grilled hamburger plate. (\$8.00 per plate for non-participants.) Meals served starting at 11:30 a.m.

**REGISTRATION ENTRY DEADLINE: Tuesday, May 23, 2023 (\$20.00 late fee per boat after May 24th)**

**CHECK-IN:** 6:00-7:30 p.m. Friday, May 26<sup>th</sup> McKenzie Pavilion in the recreation area.

**PRIZES:**

- 1) Trophies for each member of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place teams, determined by the total weight of five live fish.
- 2) Trophy and \$100.00 for biggest bass. Trophy and \$50.00 for 2<sup>nd</sup> biggest bass.
- 3) \$25.00 awarded for the biggest bass of each hour.
- 4) Bryan Marine will pay an additional \$100.00 prize to the winning team if the fish were caught from a boat purchased from them.

**RULES:**

- 1) Only CCWC lot owners who have paid the current annual dues, and their guests are eligible.
- 2) All boats must be properly registered with CCWC, and have a registration sticker, along with the lot number on the boat.
- 3) All CCWC rules and regulations must be followed.
- 4) Fish **MUST BE ALIVE** at weigh in.
- 5) All fish must be taken with artificial lures.
- 6) Fish may be weighed in at any time during tournament hours.
- 7) Fish weighed in will be released back into the lake.
- 8) Ties for team prizes will be broken by weight of the biggest fish.
- 9) Tournament Director, or appointee, will make final decision in all matters.
- 10) Upon reading these rules I agree to abide by them.
- 11) Upon signing the entry form I release CCWC and its members of any and all liabilities incurred to my property or me.
