### **Featured Speaker: Bishop Art Hodges**

Art Hodges is Bishop to more than 100 Southern California Churches. 25 are in San Diego County. He is the Senior Pastor of the South Bay United Pentecostal Church.

In May 2020, Bishop Hodges brought lawsuit in Federal Court against Governor Gavin Newsom, the State of California and the County of San Diego over unconstitutional Governor emergency orders to close church doors.

Bishop Hodges' emergency injunction request reached the US Supreme Court in just 15 days, where it was denied a hearing in a narrow 5-4 ruling. The full case is now before the Ninth Circuit Court of Appeals.

Bishop Hodges recently appeared on the Tucker Carlson Show, The Story with Martha McCallum and numerous other national and local media.

He travels extensively and speaks on conferences across the country and around the world.



## CAMPAIGN PRECINCT—Waskah Whelan

In our political past we have known of cheating in elections or at least what looked like cheating. There were rumors of cheating and results that could only have been the result of cheating such as when Al Franken “defeated” Norm Coleman in the 2008 Minnesota Senate race. After an extensive recount, Al wound up with more votes than there were adults of voting age living in the counties.

Until this year, there has never been real actual proof. Proof from witnesses willing to testify under oath that what they observed was cheating.

We have watched in amazement at all the different methods Democrats used to cheat in 2020. Stuffing the ballot box, bringing in bogus ballots from out of state by the truck load, doing away with the safeguards that guarded the security of the vote-by-mail system and by changing numerous election laws without the permission of the state legislatures. (Against Article 2, Section 1 of the Constitution.)

Witness after witness testified under oath to various state legislature committees about what they saw. They had video and documents proving cheating went on over and over.

Using death records from the social security office and the postal service national change of address data base they were able to prove that many votes were cast by non-legal voters.

The actual envelopes in which ballots were mailed were examined and voters were identified by person, by address and by precincts or wards. Names were compared to real names in official Registrar of Voter records. Actual names of voters were reviewed and compared to other voters by name, address and date of birth. This caught people registering multiple times using different variations of their first name such as Richard and Dick and those that registered twice under a married name and a maiden name. This was not just a suspicion of wrong-doing, but an actual comparison of real names and addresses to produce proof.

Attorneys and forensic data experts presented extensive evidence along with hundreds of witness documents submitted under oath.

When the facts were pieced together we saw once and for all that massive fraud did occur.

Permitting massive fraud in the state of Nevada allowed the following to happen in their vote-by-mail system:

- 19,000 voters that did not live in Nevada voted

- Underage voters

- 4,000 non-citizens voted

- 42,000 voters voted more than once.

- 1,500 dead people voted

- 8,000 voters voted using a nonexistent address

- 15,000 voted from a vacant address

- 170,000 submitted votes without application as required by law.

- 28,000 voters claimed they were *indefinitely confined* so no ID would have to be presented

- 200,000 were found to have voted illegally, but votes were still counted.

- Cheating with the mail in votes was planned: 70,000 vote-by-mail applications before 2020...690,000 afterward.

- Pennsylvania: 1.8 million absentee ballots mailed out, but 2.5 million were returned!

Thousands of voters had their voices cancelled out by fraud.

The system is forever flawed if the courts and the media simply ignore obvious cheating.

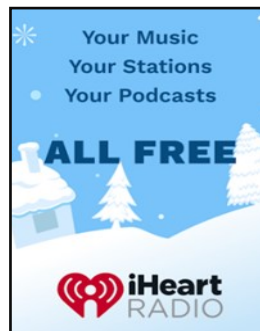
We need to work to demand that a national voter picture ID system be put in place for everyone.

Voter rolls need to be cleaned. In San Diego County, we are still over-registered. The Registrar of Voters has been taken to court twice by Judicial Watch. Both times the rolls were cleaned but not completely. Judicial Watch reported that San Diego County is one of the top three over-registered counties in the nation. The only time counties actually follow through and clean their voter rolls is when they are taken to court, sued and ordered to do so.

Please support Judicial Watch.Org and their efforts to clean the voter rolls. They are the only group that is watching the government and moving against them in court. They use the FOIA laws to compel action that would otherwise be ignored.

So, my dear friends, go forth to a New Year, filled with hope, fearless and with faith with 2020 behind you and 365 days of blank slates to be filled in!

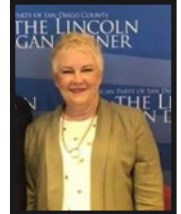
