Good morning Judy,

We received the email below from S&S contracting this morning, withdrawing their participation in the project.

This in itself is unfortunate, but the email highlights the important point that the HOA is not a member of the State-required Sunshine State One-Call of Florida organization, commonly known as 811. Florida State Statute Chapter 556 establishes the 811 system and requires that "Each operator of an underground facility in this state shall be a member of the corporation and shall use and participate in the system."

The Van Lakes HOA, as the operator of underground public water supply system, is required to be a member of Sunshine State One-Call of Florida. Lacking this, contractors will not work within the HOA area because of the lack of official utility mark-out prior to excavation. As a result of this discovery, all project work Rayl Engineering is involved with is on hold pending resolution of 811 system registration by the HOA.
