Project Description

Dodge County Wind, LLC has filed a certificate of need application, a large wind energy conversion system (LWECS) site permit application, and a high-voltage transmission line (HVTL) route permit application for its proposed 170 megawatt (MW) Dodge County Wind Farm to be located in Dodge and Steele counties and an associated 23-mile 345 kilovolt (kV) transmission line to be located in Dodge and Olmsted counties (Project). The Project would include up to 70 wind turbines, underground electric collection lines, a new collector substation, an operation

and maintenance building, permanent meteorological towers, and gravel access roads. The associated 345 kV transmission line would be constructed on single-circuit monopole structures within a 150-foot right-of-way and would connect the wind farm to the Byron Substation in Olmsted County.

Topics for Comment

- Does the certificate of need application contain the information required under Minn. R. 7849.0220, subp. 1 and 2?
- Does the LWECS site permit application contain the information required under Minn. R. 7854.0500?
- Does the HVTL route permit application contain the information required under Minn. R. 7850.1900, subp. 2 and 3?
- Should the certificate of need application be evaluated using the Commission's informal process or referred to the Office of Administrative Hearings (OAH) for contested case proceedings?
- Should the LWECS site permit application be referred to the OAH for contested case proceedings?
- Should the LWECS site permit application and the HVTL route permit application be processed jointly with the certificate of need application, i.e., joint public information meetings, joint public hearings, and an environmental impact statement in lieu of an environmental report (See Minn. R. 7849.1900, subp. 2)?
- Should an advisory task force be appointed for the HVTL route permit application?
- Are there any contested issues of fact with respect to the representations made in the applications?
