SeatChute, LLC agrees that it is our responsibility and duty to inform all customers of the unavoidable danger associated with the risk of parachuting, and we agree to recommend and sell SeatChute, LLC products only to customers who have been informed of the following risks and responsibilities:

Risks of Parachuting...

- Parachuting can cause serious injury or death.
- According to 1990 U.S. Parachute Association statistics, 0.9 fatalities occur for every 100,000 sport skydives.
- Parachutes do not always open properly. Parachuting equipment can fail even when all possible precautions are taken by you, the equipment manufacturers, and everyone else involved with your parachute.
- Failure to activate your parachute or execute emergency procedures at a safe altitude, and/or equipment failures can result in serious injury or death.

In Addition, it is also the Users Responsibility to:

- Receive proper training before using any parachuting equipment.
- Be extremely careful, cautious and prepared. Read and understand all owner and operation manuals for your Emergency Parachute System.
- Thoroughly inspect all parachuting equipment before each use.
