1) Mike Reinert with Waverly Lake Association was present to discuss the Laplant project location. So far, they have put in about 8 acres of tile to prevent the dirt runoff over the road into the lake. They have a minimum of a 10-year commitment to maintain the tile and berms. Waverly Lake Association is looking for funds to help pay for the project.

Chair, Jane Hurley communicated "where do we start and stop funding projects like this with tax payer funds?" We currently have an 18" culvert in place now under the road and it is currently functioning. A motion was made by Jane Hurley, 2ndy by Augie Riebel to deny the request for funds and carried 3-0.

New Business:

- 1) A motion was made by Jane Hurley, 2nd by Augie Riebel to pre-buy 2,500 gallons of propane from Ferrellgas at \$1.099 per gallon and carried 3-0.
- 2) Marysville Township Road Mileage Certification (42.69 miles) was signed and approved by Chair Jane Hurley.
- 3) Marysville Township Sign Maintenance Certification was signed and approved by Chair Jane Hurley.
- 4) The December meeting date will remain on December 26th, 2016.

- 1) Arnie Desmarais of 1907 2nd St NW, Buffalo was present to discuss the culvert west of his house and is looking to clean out the ditch. Jane Hurley and John Farrell each made a site visit. A motion was made by John Farrell, 2nd by Jane Hurley to clean out the ditch and evaluate the culvert and carried 3-0.
- 2) Jane Hurley and Augie Riebel will paint a handicap parking lot spot in the parking lot.
