#### Subcontractor agrees to the following:

- 1. Subcontractor's relationship to Ram-Co Trucking Services LLC will be that of a subcontractor only.
- 2. Subcontractor understands and acknowledges that all hired drivers must comply with all legal documentation.
- 3. Subcontractor represents and warrants that he/she is engaged in the trucking business and owns trucks and or trailers used to conduct his/her business and that he/she will maintain said equipment in compliance with the requirements of all regulatory agencies.
- 4. Subcontractor represents and warrants that he/she is the holder of all necessary State, Federal, County and City certificates, permits and licenses, which are required to conduct the business of transportation for hire.
- 5. Subcontractor represents and warrants that he/she is full protected by Workman's Compensation, general liability and auto insurance.
- 6. Subcontractor agrees to employ capable and reasonable employees to operate its vehicles safely and o maintain his/her vehicles to efficiently perform the services required.
- 7. Subcontractor warrants that he/she will provide and owner operated vehicle on any job that requires an owner operator.
- 8. Subcontractor will provide general information and proper documentation to realize certified payroll on required jobs.
- 9. Subcontractor is and hereby declares himself to be an independent contractor, and all employees are his/her employees.
- 10. Subcontractor agrees to obtain and pay for all permits, licenses and official inspections made necessary by his/her work and to comply with all laws, ordinances and regulations, required by each specific job.
- 11. Subcontractor understand that in the event of an injury to any employee while on the job he/she will not be entitled to any worker's compensation benefits under Ram-Co Trucking Services LLC.



- 12. Subcontractor also understands that he/she must comply with any drug and alcohol tests that are requested by any agency. Failure to comply with any request will result in immediate termination of agreement.
- 13. Subcontractor acknowledges that all employees come prepared to work with proper PPE equipment, including but not limited to hard hat, safety glasses, and safety vests or clothing.
- 14. Subcontractor agrees to turn in all tickets at the end of each day or with in a 72-hour period to insure prompt payment by prime contractor and to subcontractor. Tickets turned in late may be subject to a fine or late fee.
- 15. Subcontract agrees to invoice Ram-Co Trucking Services LLC within 7 days of work performed.
- 16. Subcontractor acknowledges that Ram-Co Trucking Services LLC will pay subcontractors invoices within 3-5 business days after receiving payment from Prime Contractor. (Generally 30-60 days).
- 17. Subcontractor agrees to Insurance Requirements as outlined and agrees to maintain insurance of the following types and amounts:
  - a. <u>Commercial General Liability Insurance:</u> to include products liability, completed operations, contractual, broad form property damage and personal injury.

Each Occurrence \$1,000,000General Aggregate \$2,000,000

 b. <u>Comprehensive Automobile Liability Insurance</u>: to include all motor vehicles owned, hired, leased, or borrowed.

Bodily Injury/Personal Damage \$1,000,000 (each accident)
 Personal Injury Protection Per Colorado Statutes

c. Workers' Compensation Insurance: Per Colorado Statutes

d. <u>Professional Liability Insurance:</u> to include coverage for damages or claims for damages arising out of the rendering, or failure to render, any professional services.

• Each Occurrence \$1,000,000

- This insurance requirement applies on to only contractors who are
  performing services under this agreement as professionals licensed under
  the laws of the State of Colorado, such as physicians, lawyers, engineers,
  nurses, mental health providers, and any other licensed professional.
- e. All insurance certificates shall be issued to include Ram-Co Trucking Services LLC as an "Additional Insured & Waiver of Subrogation". (Address 15497 County Road 10, Fort Lupton, CO 80621)
