  - on company letterhead stating hourly wage and hours work per week or current payroll history for the last 4 weeks)
- **✓**Proof of Address (CURRENT grounded utility bill, rental lease)
- **✓**Physical Exam
- **✓**Immunizations
- **✓** Dental Exam
- **✓**Health Insurance Card
- **✓**Proof of Custody (If Applicable)
- ✓ Employer's letter on company letterhead stating work schedule, school or training (for full day/full year services)
- **✓WIC and Food Stamp numbers (If Applicable)**
