- ✓ Proof of Income (TANF (DSS) Budget Letter, 4 weekly consecutive pay stubs, 2 bi-weekly consecutive pay stubs, 2016 or 2017 W-2 or 1040 Form, Employer’s letter on company letterhead stating hourly wage and hours work per week or current payroll history for the last 4 weeks)
- ✓ Proof of Address (CURRENT grounded utility bill, rental lease)
- ✓ Physical Exam
- ✓ Immunizations
- ✓ Dental Exam
- ✓ Health Insurance Card
- ✓ Proof of Custody (If Applicable)
- ✓ Employer’s letter on company letterhead stating work schedule, school or training (for full day/full year services)
- ✓ WIC and Food Stamp numbers (If Applicable)
