Fish Stocking Ken Rose reported that stocking is now complete. All county streams and lakes have received their allocations as determined by DEC Bureau of Fisheries. A total of 52,620 fish have been stocked this year.

Dutchess County Fair Booth Ken Foster reports that The Fair will be held on August 22 thru 27. Anthony Pittore and Bill Connors started restructuring the booth. Handouts and schedules were provided and volunteers should sign up as soon as possible to help determine resource availability. at next meeting. The sign-up schedule does have fewer slots to be filled this year. DCPA has already signed up to cover a full day (9 people over the three time slots). Advance tickets for volunteers working the booth will probably be priced slightly higher than previous years. Legislation Report Bill Connors reported that the Senate Crossbow Bill S1386 has been reported out of committee to the floor of the Senate for a vote. There has been no action on the Assembly version A00479.

Special Attention should be given to Bill S908/A6912. Pertains to ALL county sheriffs as additional “Issuing Authorities” for pistol permits and amendments.

Bill S135/A02299- This bill would allow possession of a pistol or revolver by a person who has applied for a license to possess a pistol or revolver and pre-license possession of a pistol as long as he or she has not been previously denied a license, been previously convicted of a felony or serious offense, and who does not appear to be, or pose a threat to be a danger to himself, herself or to others, and who has been approved for possession as long as the pistol is registered to the instruction.

The New York City Department of environmental Protection has released an interactive mapping tool that helps outdoor enthusiasts find more than 400 locations open for recreation on water supply lands and reservoirs. The RecMapper utility allows users to zoom in to any part of the watershed define recreation areas easily. Detailed property maps can be printed and users can sort areas by County, parcel size and recreational activities. Aerial imagery is available for users to see conditions on the ground before they head out. The mapper also includes
