Bexar County Emergency Services District No. 10 conducted a meeting at the Bexar County ESD Station # 1 Fire Station located at 6658 E. Houston on July 10, 2020 beginning at 7:00 P.M. The following was discussed;

- 1. Call the Bexar County Emergency Services District No. 10 Meeting to Order and establish a Quorum. President Kelley called the meeting to order at 7:01 PM and established a quorum with Commissioners Yates and Lazar present.
- 2. Citizens to be heard. (3-minute time limit per person) None
- 3. Updates from Chris Herrera, BCOEM. Unable to attend.
