My Roofer, Inc, TC Cook has been doing roof repairs and roof replacements for many years. These roofs include Roll Roofing, Ballast Roof Systems, TPO, Graveled BUR, Asphalt shingles, EPDM and Coatings. He did a complete Restoration of existing BUR Roof at 44<sup>th</sup> and Wadsworth Ave for us. The roof was leaking badly and the owner was looking for a reasonable solution that would solve the problem for a long time. He designed a solution to restore the existing roof because it wasn't blistering or delaminating and in a state that could be restored etc... The roof had 1/2:12 Slope and a good cricket system in the structure so Silicone was a good solution. TC and My Roofer came up with a spec and scope using Polyglass Silicone and all the necessary components by Polyglass to get a warranty. TC is a Certified Installer for Polyglass.

TC Planed all the existing Gravel off down to the felts, tore off the existing wall flashing and cap metal. TC then applied Asphalt Primer on the walls, applied SBS Self Adhered Base Sheet then SBS Self Adhered Modified at all the walls up and over the top of all walls. He then performed small area repairs at the small tears from the planning and minor scratch work at all embedded gravel areas. TC then applied a full coating of Asphalt Primer over the entire roof area and 8 gallons per 100 sq. ft. of Fibered Emulsion in 2 different coatings allowing each to dry before the next.

After allowing the Emulsion to completely cure, flash off and dry, TC applied a coating of Polyglass Epoxy Primer and performed all the necessary details at all scuppers, corners and pipe penetrations with Heavy Silicone Flashing Compound. Once dry, he applied 3 gallons per 100 sq. ft. of Polyglass White Silicone over the entire roof area. After that was cured he installed new painted 26ga. parapet metal at all perimeter walls.

I have known TC for over 20 years. He does great work both with both Residential and Commercial Low Slope Projects. TC has always performed per the agreements and has taken care of any issue that may have come up.



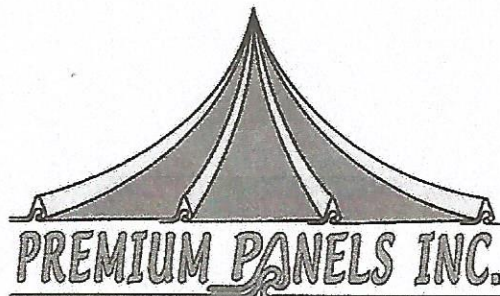

My Roofer, Inc, TC Cook has been doing roof repairs and roof replacements for many years. These roofs include Roll Roofing, Ballast Roof Systems, TPO, Graveled BUR, Asphalt shingles, EPDM and Coatings. He did a complete Restoration of existing Modified Roof System over 5 Barreled Roofs at 8000 E. 40<sup>th</sup> Ave...Direct Door for us. The roof was leaking badly and they were looking for a reasonable solution that would solve the problem for a long time at an affordable price for our budget. TC designed a solution to restore the existing roof because the 10,000 sqft of roof area had some spots that could be repaired and a large percentage was restorable.

There were 78 Roof Top Units (evaporative coolers, pipe penetrations and vent hoods) that were inactive and needed to be removed and roofed over. There were details that need to be performed at all walls, corners and transitions as repairs to the roof prior coating. There were areas that needed to be reroofed because of the existing condition was poor and leaking. The repairs at the bad leaking areas and some walls were done with Asphalt Primer, Self Adhered Base Sheet and SA Granulated SBS Modified Bitumen and the roof was water tight, wasn't blistering or delaminating and in a state that could be restored etc...

We are currently discussing roofing work we need done at my new 10,000 sqft Ballasted EPDM office/warehouse building...
