Tom reviewed the following accomplishments during the past year:

- -5 triploid carp and 100 small mouth bass have been placed in the ponds
- -new wntrance sign erected
- -road patching and sealing finished
- -done but yet to be installed are 2 " No Fishing/Swimming" post type signs for the ponds
- -Progressive Party planned and executed
- -landscaping and plantings
- -purchase of additional street lights

Tom outlined the following considuations for the next year and urged the new Board address these issues:

-Completion of the street light project -necessary road repairs and maintenance -installation of No Fishing/Swimming signs -algae and weed control of ponds -beach improvement of the North pond -repair of fence at sewage plant -extend or widen back road barricade -repair and replace plantings

A variance to the set back line was granted to Lot 18 for the potential construction of a new garage to be located on the northeast side of the dwelling. Plans for this addition must be submitted to the Board of Trustees for approval before construction may begin. The long standing issue of whether to allow or not allow the placement of realtors' "For Sale" signs in Arlington Woods was brought before the homeowners' attending. Lively discussion ensued!! A motion was made by Ted Greene and seconded by Sue Kretzschmar that---"continue to allow Arlington Woods generic signs to be erected on privately owned lots with or without homes on them." The resulting vote was 6 for and 8 against this motion. Therefore, the motion was defeated. This means that there will be no real estate signs erected on lots with or without homes on them in Arlington Woods.

Ted Greene made the motion that the above issue cannot be re-opened for discussion until the next Annual Meeting and was seconded by Sue Kretzschmar. Motion passed by all.
