We will need to wait until spring to replace some of the penstemon directly in front of the monument. Roses were trimmed. Once we get a hard frost, we'll cut down tops of roses by a foot or so to improve the visibility of the monument. We may also trim some of the pine branches overhanging the monument. The lighting of the monument looks good. The bulbs are currently incandescent, but as they burn out, will replace with LED bulbs.Replacing and mount the outlet box on the back of the monument for the holiday lighting.
