This meeting will be our annual Christmas Dinner to be held at the Gainey Ranch Golf Club, 7600 East Gainey Club Drive, Scottsdale. This is a great place to have such a function and the officers of District 23 are looking forward to seeing you there.

CHAIRMAN'S CORNER – DOUG LITTLE

I know most of you probably share my feelings of deep disappointment and sadness after the results of the November 6th election.

Many of us worked very hard and spent many hours in support of the Romney/Ryan ticket. While there are far too many to recognize individually, I'd like to personally thank you all for your outstanding efforts on behalf of the Romney campaign.

For our national Republican Party, the next few months will be a time of reflection. We will need to think carefully about what this election told us and incorporate that into our planning for 2014.

Personally, I do not agree with many of the media characterizations that the election results constituted a rejection of the Conservative agenda.

Conservatism is not done. The message of freedom and opportunity is not done. Since the Reagan administration, Republicans have articulated a message of freedom and opportunity — a rugged individualism that says if you work hard you can be what you want and do what you want.

But people forget.

We need to rededicate ourselves to becoming evangelists for Conservatism and Republican principles. We need to continue to educate and explain our vision of less intrusive government, equality of opportunity, preservation of individual liberty.

I believe that for many years, Republicans assumed everyone just naturally agreed. They stopped explaining. They stopped being evangelists. Republicans no longer articulated a core set of principles but tried to be all things to all people...they compromised with the administration when they should have been fighting. They cut deals that flew in the face of core conservative principles.

The media and the Democrats have made much of the discussion about the demographics of the Obama voters. He has tremendous support among African-Americans, Hispanics, Women and younger voters.

We must remember that not all of the losses occurred in states with heavy minority populations. Romney lost Ohio, Pennsylvania, Iowa, Wisconsin, and New Hampshire.

Romney also won the Independent vote, so our message obviously isn't turning off too many people in the middle.

The bottom line is that the demographic of single-issue voters, government dependent voters and racially based voters has grown, and they will oppose any Republican that attacks their particular issue or point of view. Moderating our stance on one or two issues will not fundamentally alter their votes.

At some point, we must figure out that if we are destined to confront an unfavorable demographic trend, we may as well stand on Conservative principle and clearly articulate that message in the hopes of changing minds and hearts.

The next Republican presidential candidate needs to have an inspirational message, money and a solid ground game to prevail.

Closer to home, we have much to be thankful for. We had many Republican victories in important races:

In our State-Wide Races

1. Jeff Flake beat Richard Carmona by a significant margin to become Arizona's junior Senator.

2. David Schweikert handily won re-election in CD 6 and statewide we hung on to 5 House seats.

3. In the Corporation Commission race, we had a sweep with all three Republican candidates winning

election. We should congratulate Susan Bitter-Smith, Bob Burns and Bob Stump on their victories.

4. We were able to preserve Republican majorities in the Arizona House and Senate.

In our County, District and City Races:

Joe Arpaio cruised to re-election as Maricopa County Sheriff Steve Chucri won his race for Maricopa County Supervisor for District 2 Michele Reagan was re-elected to the State Senate Michelle Ugenti and John Kavanagh were re-elected to the State House of Representative Suzanne Klapp, Virginia Korte and Guy Phillips were elected to Scottsdale City Council. C.T. Wright won re-election to the Fountain Hills Unified Governing Board Statewide propositions saw strong voter opposition, leading to the defeat of two tremendous threats to our Republican agenda in the form of Proposition 121 Open Primary and Proposition 204 - Permanent Sales Tax Increase.

In closing, I say to each of you...take heart, there will be other elections, other battles to fight; the most important thing to remember is, in the words of Winston Churchill, "Never Give Up, Never Give Up, Never Give Up."

I. **Call to Order** – The Organizational Meeting of LD 23 was called to order at 7:35pm at Chaparral Suites, 5001 North Scottsdale Road Scottsdale, AZ 85250. Current officers were present.

II. Pledge and Invocation - was led by CT Wright

III. **Preliminary Report of the Credentials Committee** indicated a quorum was present with 164 PCs present and 97 proxies carried. The quorum requirement is 87. Credentials then re-opened for 15 minutes.
