## Open Session

President Weber called the meeting to order. Director Bunyea led the recitation of the Pledge of Allegiance. President Weber certified the posting of the agenda. # **Staff Reports:**

A) Supervisor Miller reported a total of 14 maintenance issues for the month of January. There were 4 customer requests to turn off/on water, 0 District initiated shut-offs, 0 District equipment repairs, 0 meters replaced, 4 meters read/re-read, 2 main repairs, 3 service line repairs, 1 customer inquiry requiring investigation, and 0 sewer issues/repairs. There were also 7 new owners, 1 lien filed, 1 lien released, 64 shut-off notices, 16 non-payment shut-offs, and 5 turn-ons after water shut-off.

Supervisor Miller also reported that the Technicians are working on winter routine maintenance projects.

- B) Chief Ozias reported on the Fire Department calls for the month of January. There were a total of 9 calls, 7 were in the District, 2 were out of the district. Chief Ozias also reported that he was working on the costs for outfitting the quick-strike vehicle and would report them to the Board for approval at the March meeting.
- C) General Manager Huff reported that the account that had asked for payment arrangements at the last meeting paid their bill in full, that Running Springs Water District was turned on at their meter and are again purchasing water. General Manager Huff was reviewing the per cubic foot rate because Running Springs' rate is tied to CLAWA's rates and heir rates were increased as of Jan. 1, 2020. The General Manager concluded his report by informing the Board of the completion of the new sewer lift station controller installation and subsequent training.

President Weber excused any individuals who were not required for the balance of the meeting.

#### A) Chief Ozias

Prior to the discussion item, there was public comment from Wayne Clemons. Mr. Clemons went through some of his previously expressed concerns and gave his opinion on how Chief Ozias would respond to those items.

Chief Ozias responded to some Director questions regarding the issues. Director Wymer wanted it noted in the Meeting Minutes that she wanted to question Mr. Clemons about his public comments.
