As we reflect upon the past year, and ring in the New Year, your local volunteers, in conjunction with the National Fire Academy and the Consumer Production Safety Commission, want to help make it a safer year for you and your loved ones.

Did you know?

 More than 150 people in the U.S. die every year from accidental non-fire related carbon monoxide poisoning. Source: National Fire Academy

Carbon monoxide, or CO as it is commonly known, is a colorless and odorless gas. CO poisoning can occur when a fuel-burning appliance or machine, such as a furnace, heater or generator, is not working or vented properly. Breathing in CO at high levels can be fatal. What can you do to protect your family from the dangers of CO?

- Install and maintain CO alarms inside your home to provide early warning of CO.
- Install CO alarms in a central location outside each separate sleeping area and on every level of your home.
- Use portable generators outdoors in well-ventilated areas away from all doors, windows and vents.
- Make sure vents for the dryer, furnace, stove and fireplace are clear of snow and other debris.

Know the symptoms of CO poisoning. Because CO is odorless, colorless, and otherwise undetectable to the human senses, people may not know that they are being exposed. The initial symptoms of low to moderate CO poisoning may appear like the flu (but without the fever). They may include:

- Headache, Fatigue or Nausea
- Shortness of breath or Dizziness

While, higher levels CO poisoning may result in progressively more severe symptoms, including:

Mental confusion or loss of consciousness

- Loss of muscular coordination
- Death

Finally, as part of good community risk reduction, each household should have an emergency plan that is practiced by all residents in the home. This practice should include drills at least twice a year. Your local volunteers are looking for community partners, such as yourselves, to help us keep our community informed about the dangers of carbon monoxide and portable generators with these messages and free materials. AARP Legislation Update By Ed Bunting

The Senate recently passed the Secure Act which may foretell how Americans save for retirement. Secure - "Setting Every Community Up for Retirement Enhancement" - is designed to help more people set aside more money for retirement The act removes some of the hurdles that keep people from saving. One of its provisions makes it easier for small businesses to band together to offer retirement plans to their employees. The act also provides for long-term parttimers to gain access to workplace retirement plans. Already passed by the House, it now heads to President Trump, who is expected to sign it into law.

Former New York Mayor, Mike Bloomberg, revealed a health policy proposal on December 19th that would create a government-run health insurance plan but would not provide universal guaranteed coverage. His plan is similar to those of moderate candidates Vice President Joseph R. Biden, Jr. and Mayor Pete Buttigieg, which give Americans the option of buying public insurance but stop short of moving the entire country to a Medicare-for-all system, advocated by progressives like Senators Bernie Sanders and Elizabeth Warren.

President Trump has promised he would let the federal government force drug makers to negotiate lower drug prices covered by Medicare. The House of Representatives recently moved forward on such a policy without his help. In a strong show of unity, House Democrats passed their own legislation allowing the government to directly negotiate lower drug prices under Medicare's prescription drug program something the law prohibits. Every House Democrat voted in favor of the bill (230 - 192) after Speaker Nancy Pelosi revised it at their insistence. We'll await the response of the Senate and President Trump.

TAX AIDE By Lew Sherman District Coordinator

AARP's Tax-Aide division, a part of AARP Foundation, is once again getting ready to provide free tax preparation to those of us in the Locust Grove area. Last year, the LOW site prepared just over 400 returns, a new record. While we can't prepare tax returns for everyone (e.g., no businesses w/employees, farmers, military, etc.), we will try to accommodate everyone else. The LOW site will again work from the lower level of the Clubhouse (not the Community Center) on Fridays and Saturdays from 9:00 am til 2:00 pm, starting on Friday, January 31 and ending on Saturday, April 11, 2020.

To make an appointment, call 540-268-8837 and leave a message when prompted. Please speak clearly and slowly so that your call can be returned. **Because we want** to complete your return during your initial visit, we ask that you not call for an appointment until all your tax records have been received or located.
