## Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at [LKSAGE@aol.com](mailto:LKSAGE@aol.com) or by phone (503) 840-4303 (cell).

**SITE INFO:** This trial will be held in two rings indoors on packed dirt. There will be crating on the area outside the arena, around the bleachers. Crating space is somewhat limited, so we ask that you please conserve on space so that everyone who needs crating will be able to find a spot. Please bring chairs, crates, water and clean up tools for your dogs. **If you come and help us set up, you may set up your crating space on Thursday beginning at 3pm. Otherwise you will be able to set up after 5pm on Thursday. If you set up prior to that time, we reserve the right to move your space in order to set up the secretary tables and raffle area.**

### DIRECTIONS TO THE TRIAL SITE:

#### From North of Eugene

Travel south bound on I-5 until you reach I-105. Take the westbound off ramp (194B) into Eugene. As the freeway approaches its end on 7<sup>th</sup> Street, stay in the middle lane. This becomes Jefferson Ave. Turn right onto West 11<sup>th</sup> Ave. at the light. Turn left on Tyler Street and travel to 13<sup>th</sup> Ave. Turn left into the far right lane and take the next right into the NW entrance to the Fairgrounds.

#### From South of Eugene

Travel north bound on I-5 until you reach I-105. Take the westbound off ramp (194B) into Eugene. As the freeway approaches its end on 7<sup>th</sup> Street, stay in the middle lane. This becomes Jefferson Ave. Turn right onto West 11<sup>th</sup> Ave. at the light. Turn left on Tyler Street and travel to 13<sup>th</sup> Ave. Turn left into the far right lane and take the next right into the NW entrance to the Fairgrounds.

**MEASURING:** All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

**GENERAL:** ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

**MOVE-UPS:** The deadline for move-ups is Monday, Nov 18, 2019 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

**VOLUNTEERS:** You, the volunteers, help make our trials a success. In an effort to keep entry fees low for you and yet help the clubs bottom line, we will be offering a **DAILY worker raffle**. The workers raffle will be drawn each day in the early afternoon. Prizes must be claimed by the conclusion of the trial on Sunday.

**PRELIMINARY RUNNING ORDER:** The Preliminary Running Order is contingent on move-up entries not yet received.

**FAST CLASS WALK THRU All FAST Classes will walk together. ONE walk thru for all FAST Classes. Then we will Run all FAST Classes together by jump height.**

**Walk through groups may be changed at the trial to accommodate for workers.**

**CONFLICTS:** We will do our best to accommodate conflicts. If you have a conflict, Standard takes precedence over FAST and JWW. Put a "C" instead of a check mark on both gate sheets so the scribe and gate stewards will know you have a conflict.

**FOOD:** There will NOT be a food vendor on site at our arena. However, there is Holiday Market going on in the building across the parking lot and there will be food vendors there. Please plan accordingly. There are fast food restaurants within a couple of miles of the fairgrounds.
