## 1. AMERICAN RESCUE PLAN FUNDS UPDATE

Doc: Town Manager Scott Snow will lead the update. Scott:

1. We received $\$ 835,306.00$ August 27
2. We will receive the second $\$ 835,306.00$ in August 2022
3. We will need a budget amendment to allocate as revenue line and expense accounts
4. Transferred to new NCCMT account
5. Working with AWCK to get estimates for projects

Peggy: Do the budget amendment now?
Scott: No, not yet.
Wesley: Still the same guidelines?
Scott: Yes. Still very vague. Waiting on more input. We have until 2025.
The town has needs. Even greater needs since the pandemic.
We must report how we use the money.
Wesley: From what you have read, could the funds use tie into grant money?
Scott: Yes. Not the sidewalk project but other projects could take advantage of grant funding.
Doc: The state might add $\$ 80$ to a project.
Scott: Yes. For the sewer line in conjunction with the sidewalk project. Representative Lambeth is looking for additional allocations.
Doc: What do you have Jeff doing? (Alley, Williams)
Scott: Facility upgrades. HVAC upgrades to improve air quality. We lack space to distance in a safe way. Should we upgrade existing space or build new?
Vernon: Where would we go? We must build a new space.
Scott: Correct.
Vernon: What spot?
Scott: We have land. Jeff will advise us.
Marilyn: I'm hoping for a new, permanent space.
Wesley: I agree.
Doc: Anyone opposed?
Peggy: l'd like to see the cost of upgrading compared to building new.
Scott: We would need to get the $2^{\text {nd }}$ allocation to start which would give us time to study both.
The old fire station needs upgrades to improve air quality.
