Doc: We received the latest information about the recent Novel Coronavirus outbreak from the office of Representative Donny Lambeth. We are encouraged to increase preparedness measures. As you may already know, there are no masks available.

There have been no deaths in North Carolina from the Coronavirus. However, there have been over 150 deaths from the flu!

<u>TRANSPORTATION IMPROVEMENT PROGRAM (MTIP) AMENDMENT</u>
Doc: Wesley is our representative to the TAC.

Wesley: This is a Resolution to amend the MTIP on March 19<sup>th</sup>. New dates are backed up/delayed for both NC 66 to 2029 and 8 years for US 158. The section of I-74 from US 421 to US 158 is estimated to be completed June 1, 2020. I spoke

with Pat Ivey and he says DOT funding is in a mess. I'm posed to vote against the amendment.

Doc: When I-74 is completed it will ease traffic on US 66. They think we won't need the extra lanes on US 66. They do have stakes in people's yards but they have bought no property.

Wesley: Yes, I-74 will ease traffic in town some. On page 2 you'll see a \$343,000 payment for each year from 2020 thru 2029 to "BUILD NC NOW ROW" for NC 66.

Scott: Those are payback amounts to Build NC NOW ROW bonds.

Wesley: They are partial payments only. The Let Date for US 66 is now 2023.

Peggy: What is the outcome for voting NO.

Wesley: Just shows we aren't happy and don't approve of rubber stamping it.

Scott: Now is a good time to invite Pat Ivey to our March 12 workshop.

Peggy: Donny Lambeth and Joyce Krawiec too.

Doc: We are overdue for construction on US 158. They have been delaying construction since the 1950's. DOT answers to no one!

Council is in agreement to have Wesley vote NO on the MTIP amendment.

Doc: We are ~66% into the current year. All departments are in line.

Total expenses are at 42%. Revenue "in" at 63%, which is slow. Property tax has finally moved forward to 96%. Interest coming in well.

Scott: Expenditures are under budget. Grant funding is still out. No expenditures yet, so no spending to be reimbursed for.

Doc: Unrestricted Funds @ \$3,918,040.09 and Restricted Funds @ \$965,502.11 for a Grand Total Fund Balance of \$4,883,542.20.
