



PARTICIPATION RELEASE AND AGREEMENT

In consideration of permission to participate in NTX Practical Shooters matches to be held at Jacob's Plain Gun Club, Greenville, TX, I hereby agree and release as follows: I (print your name here) _____, hereinafter referred to as Participant, hereby release NTX Practical Shooters, its directors, agents, match officials, officers, employees and volunteers, herein after referred to as NTXPS, from all liability which may arise out of any loss, damage, injury, or death, which may befall me or any of my property or property accompanying me while enroute to or during the period of the match, and returning from the match, or while on the premises where any of the match events or social activities occur.

I hereby acknowledge that I am over the age of twenty-one (21), that I may legally possess firearms and that I will not use any skill I learn while participating in the aforementioned events for any illegal activity. I hereby acknowledged and am aware of the risks and hazards inherent in such shooting events including, but not limited to death or injury from the discharge of firearms and loss of property through misplacement or theft. I voluntarily assume all such risks.

I further acknowledge the right of NTXPS to terminate my participation immediately upon my failure, or failure of my guests, to comply with all rules, regulations, and directions of NTXPS or Jacob's Plain Gun Club.

HOLD HARMLESS CLAUSE

Participant hereby promises and agrees and understands he or she is participating in a match under the expressed condition that NTXPS and Jacob's Plain Gun Club are free from any and all liability and claims for damages by reason of any jury to any person or persons, including participant, from any cause whatsoever while engaged in NTXPS matches. Participant hereby promises and agrees to indemnify and save harmless NTXPS and Jacob's Plan Gun Club from all liability, loss, costs, and obligation of any kind on account of or arising out of, any such injuries or losses, however occurring, during the period the participant, or guests, are participating in match events and social activities related thereto.

COVENANT NOT TO SUE

Participant hereby promises and agrees they, will not, nor will anyone acting on their behalf claiming by or through, bring or maintain any suit in Court to assert any claim against NTX Practical Shooters or Jacob's Plain Gun Club, nor institute, prosecute or in any wai aid in the institution or prosecution of any claim, demand, action, or cause of action for damages, costs, loss of services, expenses, or compensation for or on account of any damage, loss or injury either to person or property, or both, resulting or to result, past, presnt or future, arising out of the said privilege of participating in NTXPS matches.

I further state that I have read the foregoing Participation Release and Agreement, Hold Harmless Clause, and the Covenant Not to Sue and freely enter into them on behalf of myself and my distributes, heirs, next of kin, executors and administrators.

This instrument shall remain in full force and effect indefinitely.
