

Continuing Teacher and Leader Education (CTLE) and Me ~

• Who is required to complete CTLE (Continuing Teacher and Leader Education) hours? Professional



certificate holders (teachers who received their certification after 9/1/2004) must complete a minimum of are 100 clock hours of acceptable CTLE during each 5 year period. Permanent certificate holders are not subjected to these rules.

• When does the five-year period begin? The five-year registration period begins when you registered as a "Registered" member in the TEACH system. Individuals who were issued their first Professional certification starting 7/1/2016 will be automatically registered for their initial <u>five-year registration</u> <u>period</u>. The registration period will begin the first day of the month when the certification was issued until the end of the month prior to their birth month in the fifth year.

- What organizations are considered a sponsor and can deliver professional development hours? The West Genesee Central School District is an approved sponsor; therefore, any professional development you received during staff development days or half days and Superintendent's Conference days, count towards CTLE hours. Additionally, professional development offered by BOCES, NYSUT Education and Learning Trust, courses offered through the West Genesee/Syracuse University, as well as, credit-bearing courses from accredited colleges and universities.
- Is there a Language Acquisition requirement? Of the 100 required CTLE clock hours, fifteen percent must be in language acquisition addressing the needs of English language learners, including a focus on best practices for co-teaching strategies, and integrating language and content instruction for English language learners.
- Who is required to keep track of CTLE hours? <u>CTLE certificate holders</u> shall maintain a record of completed CTLE, which should include the following information: the title of the program, the total number of hours completed, the number of hours completed in language acquisition addressing the need of English language learners, the sponsor's name and any identifying number, attendance verification, and the date and location of the program.

Sick Leave Bank Update



Our Sick Leave Bank is now in its second year. Of our 400 WGTA Members, 388 (97%) are currently enrolled in the Sick Leave Bank. Over the course of the past year and a half, the Sick Leave Bank has provided six of our members with challenging health conditions, some financial stability. Thank you to all of our members who have donated days. Your generosity has helped some of your fellow members through a difficult time. The majority of us will not end up accessing Sick Leave Bank days; however, this benefit acts as a safety net in case an unfortunate event occurs and someone's sick days have been exhausted.

Below you will find some reminders and information regarding the Sick Leave Bank:

- At the time of publication, the Sick Leave Bank will have approximately 700 days.
- Sick days are NOT donated to the bank each year. The initial donation of 2 days was required for membership.
- In the event that the Sick Leave Bank drops below 90 days, members will be required to donate an additional day.
- A member may request days from the Sick Leave Bank only after he/she has exhausted all accumulated sick days. Sick Leave Bank days can only be granted for absences due to an individual's prolonged illness or injury. A prolonged illness or injury is an illness or injury that is serious in nature and necessitates an extended absence from work for multiple, consecutive days. The general accepted time frame of a prolonged illness is two consecutive weeks. An employee does NOT have to use any unpaid days prior to petitioning the committee for days.
- Maternity leaves do not automatically qualify for approval by the Sick Leave Bank Committee. If there are extenuating circumstances, either prior to or after delivery, the Sick Leave Bank Committee will consider authorizing approval of the leave, provided the person requesting the leave has been deemed unable to work by her doctor and appropriate documentation is provided.
- Elective surgeries and recovery from such surgeries are not covered by the Sick Leave Bank.

The salary for an individual who is granted days from the Sick Leave Bank is paid at a rate of BA +0, Step 1 which is at the bottom of the salary grid.

Why Disability Insurance?

The need for disability insurance is often overlooked by most. Of the many types of insurance, disability insurance is very important to have but often overlooked. According to the American Council for Disability Awareness, 1 in 4 Americans will experience a disabling illness at some point in their lives. With those odds, taking your chances without disability insurance can have a devastating effect, both financially and personally. Imagine being both sick and without an income.

If you have over a million dollars invested, then you don't really need to have disability insurance. You are selfinsured. For the rest of us who don't have a million dollars, disability insurance is required to protect us in the chance we can't work for long periods of time (90 days to 15+ years).

If you become disabled (too ill to work), you have your available sick days as well as 90 days of sick bank days. That is if you have officially joined the WGTA sick bank. So, what happens after you run out of sick days and sick bank?

This is where disability insurance comes in. You can purchase disability insurance that will cover a certain percentage of your income for short and long term illness. It is a good idea for everyone to have good long term disability insurance that will provide you with protection up to retirement age.

The average cost for disability insurance is \$37 per month (\$444/year). NYSUT members have access to discounted disability insurance through Metropolitan Life (administered through MERCER)
