- Aaron Thompson, Land Use Specialist, UW-Extension Center for Land Use Education, "Over 300 people weighed in on the Big Eau Pleine—now what?" provided discussion and interpretation of Big Eau Pleine rural landowner and waterfront property owner survey results at the August General Meeting. There was a 73% response, which is well above the normal response rate to surveys of 10-15%.

2016

- Supported Walleyes For Tomorrow with their drive to stock three million fry into the Big Eau Pleine Reservoir
- Eighth Annual Meeting and Picnic held at Hotchkiss's Last Cast.
- 2016 Fall BEPCO Boat Tour with area farmers, local & state government officials, BEPCO members, & DNR staff. The participants were given pontoon rides to observe some of BEPCO'S Projects and to network regarding shared concerns about the status of the Big Eau Pleine Reservoir.
- Participated in the initial meeting of the Lake Management Grant Advisory Board, which will address the Memorandum of Agreement (MOA) with interested parties to the operation of the Aerator.

2017

- BEPCO involved with partners to update the Memorandum of Agreement for the operation of the aerator

- BEPCO members rebuilt the Life jacket Kiosk at the Maryel Boat Landing after the previous Kiosk was vandalized.
