## **GOVERNING BODY**

Commissioner Gwin asked City Attorney Solander about title work done on Denise's Café. City Attorney Solander commented he did not want to mislead the purchaser and sought an open commitment with the title company to determine longevity of tax liens.

Commissioner Gwin asked about the status of the Water Plant. City Manager Weiner commented the biggest hurdle is the park conversion. He also commented the State of Kansas is assessing if we can reuse one of our clear wells. City Manager Weiner also mentioned we need to camera our backwash lines that go to the lagoons to make sure the lines will be sufficient with the water pressure of the New Water Plant.

Commissioner Gwin asked about the contract for the land acquisition. City Manager Weiner commented Mr. Mundell proposed the City purchases some additional land from him that would extend down the boundary of Sandra's Quick Stop. Commissioner Cole asked if this ground could be used to create additional campgrounds. City Manager Weiner said it would be possible but would have costs associated with the project such as leveling ground, running electric and water lines, and electric pedestals. Commissioner Gwin commented he was in favor of purchasing the additional land as it was being offered at a very reasonable price and would open a lot of doors. Mayor Brecheisen-Huss and Commissioner Cole both agreed.

Commissioner Cole commented she was in favor of the additional land acquisition.

Mayor Brecheisen-Huss thanked the Department Heads for their reports they provided. She was also pleased with seeing the report from the new Building and Zoning Inspector Garrett Gross as well as the Police Department breakdown of code enforcement.
