Set-up/Hours of Operation/Teardown: Please refer to the event information for setup and tear down times. Vendors are asked to operate for the whole event.

Insurance and Hold Harmless All vendors and exhibitors must have their own liability insurance. Vendor is solely responsible for all dealings and actions, and agrees to hold Dancing Spirit Inc, the ELHI Association, its board, employees, members, supporters, partners, sponsors, volunteers, advertisers, the Town of Ignacio and the Ignacio School District harmless from all claims.

Legal Compliance/Taxes Vendor agrees to comply with all laws, licensing, permits, and health department regulations. Vendors are solely responsible for payment of all state and local sales tax as a result of any sales made during this event.

Questionable Products Dancing Spirit Inc reserves the right to inspect, approve, reject or otherwise control the display, promotion or sale of products or services at its sole discretion.
