



Hunting and Trapping Regulations

1. **No alcoholic beverages, drugs or foul language.**
2. **No trapping between the middle of September (15th) and the end of all combined deer seasons.**
3. **No guns (Only LTC holders may possess a firearm). No Exceptions!**
4. **No cutting trees larger than 1" to set up a stand.**
5. **Anyone wishing to set up a trap must clear it with the Club Vice President.**
6. **No individual may have more than two traps.**
7. **All game harvested must be registered with Club Vice President no later than 8am the following day.**
8. **Respect fellow hunters. Do not set a stand or trap within 100 yards of an existing deer stand. Spread out! All stands will be kept a minimum of 75 yards from the Robert Hale Practice range.**
9. **All hunters must have completed a Hunters Education Course. (Deferred for 2012, Required 2013)**
10. **All hunters must be current members and have qualified to purchase an Access Permit from the club.**
11. **All hunters must demonstrate their ability to hunt ethically by shooting at least a score of 140 using a compound bow or a 112 using traditional equipment on a 20-target course. This will be done using the data from any one of the five qualifying shoots required to purchase a permit.**
12. **Current access permits must be displayed in your vehicle window at all times while hunting.**
13. **All hunters must hold a valid Texas hunting license.**
14. **All hunters will, without question, present all permits and licenses to ANY club officer, Texas Parks and Wildlife Game Warden, Paris Police Officer or Lamar County Sheriff' Officer or deputies when requested.**
15. **All qualified AFC hunter access permit holders will stay inside the boundaries of lease as displayed on attached AFC map.**
16. **Access Permit holders are allotted 4 stand locations only. Name and phone must be visible on stands. A main map located at the Pavilion will have 4 pushpins with your access permit number on them. A stand must be identified on the main map with a push pin one week prior to opening day of Archery Season.**
17. **There will be a Zero tolerance for violation of club rules. Access permits are a privilege and will be revoked or terminated for the present hunting season up to a period of at least one year for violations.**
18. **ALL ATV/UTV will be kept on established roads. (There are only two roads designated for ATV traffic. The Point RD and North RD.) There will be no leaving the road to drive to stands or feeders.**
19. **All ATV/UTV traffic will cease 30 mins before legal shooting hours (it is your responsibility to know when that is as it changes daily) and will not begin again until 10 am. All ATV/UTV drivers will use common sense/courtesy while using designated roads from parking areas to hunt and back again. All ATVs/UTVs will park right beside one of the main roads and the hunter will walk to their stand. Do not block main roads!**
20. **Any violation of club rules or attempting to misinterpreted club rules will be dealt with on an individual basis by club officers. Violators will be suspended from all AFC lease privilege, effective immediately until officer's review and make a final determination on length of termination.**
21. **Remember this is your lease, treat it with the respect and dignity as you treat the AFC 3-D Tournaments.**
22. **We are Blessed to have a great place to call our own, and have been asked to manage it with respect. Any qualified hunter deemed as abusing this lease privilege will be asked to leave.**
23. **All hunters will make every effort to coordinate their arrival and departure times to their respective stands so they do not interfere with another hunter's efforts. We all know there are persons that work different shifts and may hunt during different hours. Act respectful to each other and work it out or lose your permit. Arguments will not be tolerated. Treat this lease as you would public land, because it is.**
