DORCHESTER BY-LAW AMENDMENTS

CURRENT BY-LAW	AMENDMENT
<p>Article 1, Sec 2 – Class of Members the second class of membership shall be an individual membership, which shall consist of one individual who will have one unlimited guest privilege; if the individual holding said individual membership later becomes married, then his or her classification must be changed to a family membership</p> <p>Article 1, Sec 7 – Transfer Fee the transferee shall pay to the Club a transfer fee of twenty-five dollars (\$25.00), plus taxes</p> <p>Article 4, Sec 1 – Officers and Duties The officers of the Club shall be a President, a Vice President, a Secretary and a Treasurer.</p> <p>Article 4, Sec 5 – Officers and Duties The Treasurer shall collect all entrance fees, dues, and other money, and receive and hold all securities of the Club, and shall deposit the same as directed by the Board.</p> <p>Article 4, Section 6 – Officers and Duties</p>	<p>Article 1, Sec 2 – Class of Members the second class of membership shall be an individual membership which consists of one primary adult only, married or unmarried, who will be the sole stockholder and member. Children cannot be added to this membership. This membership will be allowed one free guest pass per visit.</p> <p>Article 1, Sec 7 – Transfer Fee Delete</p> <p>Article 4, Sec 1 – Officers and Duties The officers of the Club shall be a President, a Vice President, a Membership Secretary, a Financial Secretary and a Treasurer</p> <p>Article 4, Sec 5 – Officers and Duties The Treasurer shall receive and hold all securities of the Club as directed by the Board.</p> <p>Article 4, Section 6 – Officers and Duties The Financial Secretary shall collect, deposit and keep track of all dues and other payments from members. He shall perform other duties as directed by the Board and shall be co-chair of the Finance and Legal Committee.</p>
