CALL FOR NOMINATIONS! 2019-20 ANNUAL AWARDS ASPA SACRAMENTO

Since 1982, ASPA Sacramento has honored individuals, programs, and organizations for excellence in the field of public administration. Award recipients must reside in Northern California and must be part of:

- any level of government (federal, state or local), or
- academia related to public service and/or public administration, or
- non-profit entity involved in public service and/or public administration.

ASPA Sacramento will announce recipients in March and present the awards at our annual dinner in May. The seven award categories for 2019-20 are:

AWARD CATEGORIES

Elizabeth Hill Public Official of the Year

Presented to a non-elected professional administrator who demonstrated excellence in public management over a sustained period of time.

Community Service

Presented to an individual or organization for sustained leadership in addressing public policy issues or improving life in Northern California.

Government Innovation

Presented to an individual or organization for implementation of a new program, policy, system, or solution that significantly improved a public service.

<u>Grantland Johnson Intergovernmental Cooperation</u>

Presented to an individual or organization for development and delivery of a program or policy between different levels of government, resulting in greater efficiency.

Rising Star

Presented to a public professional, teacher, or researcher, 35 years of age or younger, who has made noteworthy contributions to effective government or academia in the early stages of a promising career.

Chester A. Newland Academic Excellence

Presented to a college student, teacher, administrator, or organization that has demonstrated scholarship and leadership in public administration or a closely related field of study, or that has made a noteworthy contribution to the education of public administrators.

Ross Clayton Lifetime Distinguished Public Service
Presented to an individual for especially meritorious service in the field of public administration over the course of a lifetime.

DECEMBER PROGRAM NOTES

Our December program delivered information and discussion about an always important subject: leadership. The complete title was "Daring Leadership: Rumbling With Vulnerability." USC State Capital Center provided our location and the audience provided interest and enthusiasm for the topic.

ASPA Sacramento President Juliet Lee welcomed everyone. She called the evening's program a teaser for a much longer workshop, and she introduced:

- Ana Estrada Daniels, President and CEO of Anavo Solutions
- Beth Conley, President and CEO of To The Point Facilitation, Inc.

Juliet also introduced National ASPA President Paul Danczyk, who furnished background on ASPA: 53 chapters, 26 sections, and a 2020 conference to be held in Anaheim. Paul thanked Ana and Beth for their involvement with ASPA and their work on leadership.

Ana Estrada Daniels promised "lots of interaction tonight" and she described her and Beth's efforts as "all about connection." In their workshops, Ana and Beth employ the research of Brené Brown and her Dare To Lead™ model. Ana shared some biographical information about Brown (books, social work, and teaching), and she reiterated Brown's declaration that "Courage is teachable."

Ana cited four skill sets of courage:

- Rumbling with Vulnerability
- Living into Our Values
- · Braving Trust, and
- Learning to Rise.

Ana asked the audience to think about 1) Where do you want to be braver as a leader and 2) What is the issue you feel is too hard to take on?

The audience then watched a short video of Brené Brown speaking about leadership and vulnerability. Ms. Brown declared that all of us should "lean into vulnerability" and that admitting one's vulnerability gets you to courage.

Ana and the audience commented on the video:

- Courage is contagious.
- Anyone can be a leader.
- Brown talks leadership for both men and women.

In a second video, Brené Brown addressed **six myths** and misunderstandings that people have about vulnerability:

- 1. Vulnerability is weakness.
- 2. Strong people don't do vulnerability.
- 3. Strong people can go it alone.
- 4. You can engineer uncertainty out of vulnerability.
- 5. Trust comes before vulnerability.
- 6. Vulnerability is disclosure.

Ana finished with observations about "stepping into the arena," which is Brené Brown's term for confronting your problems and challenges, something every leader has to do. These obstacles can be things like a new job, an important meeting, or a sensitive conversation.

"The arena" contains sections of people that will react to you "stepping in." Brown identifies four sections:

Cheap Seats

People hurling advice and judgment who rarely "step in" themselves

Box Seats

People who "built the arena" and will determine your success (sometimes with misinformation and fear)

Season Ticket Holders

Critics who give negative messages of comparison, scarcity, and shame (often with a slanted view)

Support Section

People who have empathy and compassion for your decision to "step in"

Ana asked the audience to read the handouts we didn't cover, which include more information on the arena concept, courage, and dealing with emotion.

Throughout the program, Beth Conley made several drawings that connected the various parts of the presentation. Several audience members stayed for the drawings and additional discussion. People interested in more information about the full workshop can reach out to Ana at ana@anavo.solutions.
