

Perkins V: Strengthening Career and Technical Education for the 21st Century Act

On July 31, 2018, the president signed the Strengthening Career and Technical Education for the 21st Century Act (Perkins V) into law. This Act, which became Public Law 115-224, reauthorizes the Carl D. Perkins Career and Technical Education Act of 2006 (Perkins IV). It was approved unanimously by both chambers of Congress, reflecting broad bipartisan support for career and technical education (CTE) programs. Perkins V is largely based on the structure and content of current law, but makes some key changes that will impact the implementation of CTE programs and administrative processes around the country. As the new law was making its way through the reauthorization process, a key area of debate was "Secretarial authority" or the role of the U.S. Secretary of Education (Secretary) in the process of state and local planning and accountability. In Perkins V, we see evidence of the compromise on this issue, with enhanced prohibition language that limits the Secretary's role and the elimination of the negotiation process between the Secretary and states on performance measure targets. In turn, we also see more specific requirements for setting these targets, including additional stakeholder engagement and expanded definitions.

The new law will go into effect on July 1, 2019, and the first year of implementation will be considered a "transition year." Eligible agencies will be able to submit a one-year transition plan in spring 2019. Full four-year state and local plans, covering all the requirements of the Act, will then be submitted in spring 2020 (encompassing program years July 1, 2020-June 30, 2024).

Major Tenets of Perkins V

Perkins V maintains a focus on CTE program improvement, flexibility, and data and accountability. The new law:

- maintains a commitment to driving improvement through programs of study and includes a robust, formal
 definition of that term
- retains the state governance structure of current law, as well as formulas for local funding flowing to public or nonprofit educational institutions
- updates the federal-to-state formula to ensure states receive no less than their Fiscal Year 2018 funding levels as long as funding is not cut overall (and then providing for equal, ratable reductions for all states)
- increases the allowable reserve fund to 15 percent to spur local innovation and implement programs of study
- introduces a comprehensive local needs assessment that requires data-driven decision-making on local spending, involves significant stakeholder consultation and must be updated at least once every two years
- creates a new competitive grant program within national activities focused on innovation and modernization
- lifts the restriction on spending funds below grade 7 and allows support for career exploration in the "middle grades" (which includes grades 5-8)
- defines who is included in the accountability system by including a formal "CTE concentrator" definition, instead
 of leaving this definition up to states
- significantly changes the process for setting performance targets by eliminating the negotiations with the Secretary and replacing these negotiations with a new list of requirements for developing targets and including those targets in state and local plans
- shifts the accountability indicators; the most significant changes are the consolidation of the two non-traditional
 measures into one, and the elimination of the technical skill attainment measure, which is replaced with a
 "program quality" measure at the secondary level that requires states to choose to report on work-based learning,
 postsecondary credit attainment or credential attainment during high school
- focuses on disaggregation of data by maintaining the required disaggregation by student populations, requiring
 additional disaggregation for each core indicator by CTE program or Career Cluster, and referencing attention to
 this disaggregation and identified performance gaps throughout the Act
- increases the focus on serving special populations with a new purpose of the Act, expanded definition, new
 required use of state leadership funds, additional consultation and stakeholder involvement, and new GAO study

Tribute to Margaret Johnson (10/30/1920 to 03/31/2018) By Sheryl Pienig Keller; Milford, Nebraska

I was saddened when I learned at the MPBEA summer conference Presidents' Reception that Margaret Johnson, former University of Nebraska business teacher, had died.

Margaret was one of my instructors at UNL. I remember she was always dressed in something colorful, her hair was always immaculately styled, and she always wore heels. I can still hear them "clacking" on the floor of teachers college in my undergraduate years and then later in Nebraska Hall when I returned to get my master's degree.

Dr. Margaret Johnson taught at North Texas State University, the University of Arkansas, and 24 years at the University of Nebraska, Lincoln. During her tenure at the University of Nebraska, she cosponsored the Alpha Upsilon chapter of Delta Pi Epsilon, and served as the Nebraska State Advisor to Future Business Leaders of America-Phi Beta Lambda.

She served as president of the Nebraska State Business Education Association, president of MPBEA, member of the national Policies Commission for Business and Economic Education, and on the NBEA Executive Board.

She received the MPBEA Leadership Award, 1977; NSBEA Service Award, 1979; Outstanding Graduate Student in Business Education, North Texas State University, 1957; and Nebraska FBLA Outstanding Service, 1968.

When I was Past President of MPBEA in 2013-2014, I was in charge of inviting other past presidents to the annual presidents' reception in Dallas, Texas. I knew she returned to Texas in the summer, and she returned the day the conference started. However, her daughter had driven them for 11 hours from Tucson to Seymour, Texas. Margaret said she was too exhausted to drive any further.

At the time, my oldest daughter lived in Gilbert, Arizona (a suburb of Phoenix) and only about 90 miles from Tucson. I visited my daughter several times a year to help with her children. On one of my visits to Gilbert, I decided to borrow my daughter's car to visit Margaret in Tucson. We had a blast.

I arrived at Margaret's home about 11. Even though we were going to lunch, she insisted on serving me a breakfast roll and iced tea. I sat in her lovely living room while she walked back and forth from the kitchen to the living room--insisting on serving me--her shoes clacking on the tiled floor. Her home was in the hills to the east of where I had entered Tucson. I drove up a winding road to get there. She lived on a small acreage surrounded by other small acreages with lovely desert landscaping. Margaret's desert included landscaping colorful blooming flowers and bushes amidst the gravel and sand and a glistening pool. She told me she had never used the pool and that someone else was now doing her landscaping.

She told me she was delighted to have me visit. She said she was just thinking that a lot of people who used to visit her no longer came. She was a little sad about that. Then her next thought was, "Well, most of them have died!" When we did leave for our restaurant destination, a few miles down the road, I drove. She told me she still drove in the area, but that she did not take any roads where she might have to make a left turn without a signal. She was now in her 90's. The restaurant was up several flights of concrete steps, but she had no difficulty conquering those.

We sat on an outside, shady balcony for our lunch; even though it was



Tucson, it was quite pleasant. Margaret told me about one of the groups to which she belonged. The group met on a regular basis. During their meetings, the group discussed a pre-selected topic. Margaret frequently did a little research to present information on the topic and the group would then discuss. She seemed to really enjoy this. After our visit in Tucson, she took on the challenge of learning to play bridge because so many of her friends already did so. Margaret exemplified the saying that you are never too old to learn!

After lunch, we returned to her home and chatted like old friends who had not seen each other for a long time.

I occasionally called Margaret and occasionally wrote her. I sent her pictures of my grandchildren, so she could put a face to a name because we grandmas have a tendency to frequently mention our grandchildren. She framed one of the group pictures of my grandchildren! She thought it was "wonderful" that I could be so involved in my grandchildren's lives.

In the summers (June to October), Margaret would return to Seymour, Texas, so she could be close to her daughter, Carolyn, and to participate in the annual Old Settler's celebration. She would either fly,

Carolyn would pick her up and take her, or Margaret would hire someone to drive her to Seymour in her car. She would then pay airfare for the person to return to Tucson. Even in Seymour, she liked to have her car. The annual Settler's celebration included a community picnic. In her 90's she was thinking she would win the award for the oldest there. She was a little perturbed because "some old woman attended' and beat her out. A couple years later, Margaret did win that award.

In 2015, the MPBEA Board planned a conference in Albuquerque, New Mexico. Although Margaret would have to fly, I called her to plant the seed to attend. I then found a flight I thought would work for her, and to my delight she made plans to attend the conference and the President's reception. She said her friends had told her she was crazy to take this on at her age, but she highly anticipated attending the conference.

Margaret was enthralled by the new and renewed friendships she developed at the MPBEA conference, the new knowledge she gained, being called Queen Margaret by Gary Schepp and other Texans, and getting to know her escort. Her escort was a student of Sherrill Wheeler's and a national officer for Business Professionals of America. Margaret admitted that she was a little shaky on her feet and might need someone to keep her stable.

Margaret was amazed to see how business education had evolved since her retirement in 1987. As a former teacher of shorthand, I think she had thought business education would disappear when schools discontinued teaching shorthand. Queen Margaret glowed as she sat in conference sessions, and she talked about her conference experience for months after.

After the conference, she shared that her 95th birthday was coming on October 31, 2015. I posted messages to the MPBEA Board and the Nebraska list serve. I do not know how many cards and notes she received, but she was elated. She said those Nebraskans really made her day! Carolyn even sent a thank-you for making her mom's day extra special. She even received a card and note from her MPBEA escort. She was impressed with him. She said, "That young man is going places!"

Last fall, I phoned Margaret and discovered that she had reached the point where she needed assistance in her home. We still chatted, but I could tell that even her voice did not have the same energy.

I did not know of her death until the MPBEA conference in Omaha this year. Even though I knew it was coming, I was saddened to actually hear the news. I shed a few tears that night. Margaret Johnson left her mark in my heart and in the world of business education.

Margaret is survived by her daughter Carolyn Bomberger and husband, Gregory of Seymour, Texas, nieces, nephews and many friends.

The world has lost a great teacher and promoter of business education, who exemplified what it means to be a "professional." She believed in the added value of being involved in the professional organizations. She lived a good, active life, serving others throughout her life. I will miss her, but I am glad I had the opportunity to reconnect with her after so many years! I am glad that business educators from this region, and especially, Nebraska, brightened her years! As Margaret would say, "You Nebraskans are the best!"


