AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS AND COVENANTS FOR MCCLAREN MILL CONDOMINIUM

The location of parking spaces assigned to the Units are permanently changed and assigned as indicated in the attached Exhibit "A". Unassigned 'free' parking spaces and handicapped parking spaces are also located as indicated in said Exhibit.

ALL OTHER PROVISIONS OF SAID DECLARATION SHALL REMAIN UNCHANGED.




