September 21, 2020

The regular meeting was called to order by President Kevin Sluder at 7:00 p.m., Monday September 21, 2020. Village Clerk Report - Heather Sherman

- It will cost \$4800 to clean the water tower before painting is done. Being so late in the year the board has decided to wait until spring to clean and paint the water tower.
