Allergy season is here!

Along with drastic changes in weather--it being cold one day, and hot the next--you may notice more runny noses, coughing and sneezing among children. Germs spread especially easily between children when they place things in their mouth and then share them with their peers. Therefore, it is essential that cleaning, sanitizing, and disinfecting practices are in line with recommended best practices to protect the health and well-being of every child. As you know, cleaning, sanitizing, and disinfecting reduce the risk of illness by decreasing the growth and spread of bacteria, viruses, fungi, and mold.

What is the difference between Cleaning, Sanitizing, and Disinfecting?

Cleaning is the physical removal of germs (bacteria, viruses, or fungi), dirt, and other organic material by scrubbing with water and soap or detergent. It is the most useful method for removing germs from surfaces. When selecting eco-healthy cleaning products choose from those that are certified by 3rd parties such as <u>Green Seal</u>, <u>EcoLogo</u>, and <u>EPA's Safer Choice</u>

A sanitizer is a product that reduces germs to a safe level, as judged by public health standards. Sanitizing is appropriate to use on inanimate surfaces and products such as: food contact surfaces, toys, and pacifiers. Disinfecting destroys or inactivates most germs on non-porous surfaces like: diaper changing tables, counter tops, door handles, toilets, and other bathroom surfaces. It is important that you clean a surface with soap and water first, before sanitizing and/or disinfecting it. Since sanitizing and disinfecting agents kill germs they are considered pesticides. As such, when they are needed, it is important to select only those products registered with the U.S. Environmental Protection Agency (EPA). The majority of U.S. child care facilities use bleach, a known chemical irritant, to sanitize and disinfect, because it's familiar, easily accessible, economical and, when used correctly, effective. However, bleach can cause irritation to the lungs and skin if not used and/or diluted properly. Fortunately, bleach is not the only product that sanitizes and disinfects.

What are other alternatives to bleach?

Many parents and guardians are concerned with respiratory difficulties and skin irritation associated with bleach exposure, and thus, they seek alternatives for sanitizing and disinfecting. Products with hydrogen peroxide as the active ingredient can be used as alternatives to bleach. Hydrogen peroxide breaks down to water and oxygen and does not leave harmful residues nor introduce irritating fumes into the air. There are also a few botanical-based disinfectants available that are EPA registered and fragrance free. Some of these may cost a little more than their counter parts, but the price difference are typically negligible.

Whether selecting a bleach product or a hydrogen peroxide-based or botanical-based product, make sure to always check the associated label to ensure that it is EPA registered. Additionally, it is vital that all product directions for sanitizing and disinfecting are followed closely. Finally, baking soda and dish soap mixtures, vinegar, and borax are great low-cost cleaners, but they do not kill germs well enough to be used to sanitize or disinfect.

- 6. Some children will want to poke and pull at the mixture, finding the feeling fascinating.
- 7. When finished, let thoroughly dry. Some of the salt might flake off if there was not enough glue.

TAKE ACTION!

April is National Child Abuse Prevention Month. For the tenth year, communities are encouraged to "do 1 thing" for children – get involved by simply "Building a Blue Ribbon Tree" and displaying the trees during the month of April. The blue ribbon is the international sign for child abuse prevention and serves as a constant reminder that all of us have a responsibility in helping protect children.

Where do I participate?

Anywhere in Oklahoma

When do I participate?

It is recommended that "Ribbon-ed Trees" be on display before April begins or any time during the month of April. Everyone is urged to complete the official Tree Registry by sending in the registration card (next and no more than two photographs. Tree photos received by the deadline will be featured during a slideshow at the 25th Annual Oklahoma Child Abuse and Neglect Conference (hosted by the Center on Child Abuse and Neglect) as well as a variety of other ways including the official 2018 CAP Month Scrapbook.

How do I participate?

Any community group or individual has the power to "Do 1 Thing" to promote child abuse prevention. "Build a Blue Ribbon Tree for Kids" with the rest of the state.

- 1. Select or construct a tree (if constructing choose any materials)
- a. If utilizing a 'live' tree, choose one that has high visibility;
- b. If constructing a 'unique' tree, creativity appreciated and encouraged.
- 2. Decorate tree with blue ribbons (store bought or home-made *flagging tape works wonders*)
- a. Hang ribbons on trees to represent any of the following:
- The number of new babies born in your community;
- The number of confirmed child abuse and neglect cases in your county;
- Something significant to your agency, program, or community; (i.e. number of families served by your program/agency)
- Or use the ribbons to show your community support for children in general; (benefit of this selection
- − *NO counting ribbons)*

We are excited to share that the following items are now available on CECPD's website, accessible to providers and anyone who is interested:

Oklahoma Quality Child Care Program Scale: Self-Assessment.

A short (approximately 15 minute) video training is now available on CECPD's website about the new self-assessment scale*. This video will help programs become familiar with how to use the scale and also assist them in understanding more about the Oklahoma Core Competencies as well as the program evaluation process required for Stars. Two Star programs (homes and centers) need to complete the self-assessment tool before November 1, 2018 prior to updating their program goals and then annually thereafter. (Please keep the completed document at your program for licensing staff to review.) Nationally accredited programs and Head Starts are not required to complete the self-assessment scale. The video training is voluntary and is located at www.cecpd.org in the Resources tab and under QRIS Video Training.

OBI Live Scan Office & Mobile Unit Fingerprinting Instructions

The Office of Background Investigations pleased to announce that we are now providing fingerprinting services to DHS applicants!

OBI opened a Live Scan office in the Sequoyah Building, located in C-26, Hours of operation are Monday – Friday from 8:00 am until 5:00pm.

The OBI Mobile Fingerprinting Unit will visit 15 county DHS offices each month, to assist DHS applicants obtain fingerprinting services. Please beware that these counties may change, as new vendor sites are opened in areas currently under served by Live Scan vendor sites. Hours of operation are Monday – Thursday from 9:00 am until 5:00 pm. Current Mobile Unit

- * Add up to 5 pictures to showcase your program to families


