**Summary:** Most expenses had been received and paid by September 26<sup>th</sup>, while all expenses for the month of August had not been received and paid by August 15<sup>th</sup>. This made for most of the difference of \$2,353 in the Operating Accounting.

The Treasurer pointed out that the financial reports showed pipe leak expenses on separate lines for plumbers, unit labor and unit material expenses. The reports also show income from the Pipe Leak Repair Fund on its own line. There was no transfer of funds to or from the Reserve Account to or from the Operating Account during period. Reserve Account Interest for September was not yet posted.

- **c.** Spa operating hours were discussed. The Spa will open at 7 a.m. every day. It will close at 10:00 p.m. Sunday Thursday and at 11:00 p.m. Friday and Saturday. Also, glass bottles, plates, drink containers, etc., are not allowed anywhere in the Spa area. One of our homeowners (see above no. 7.b.) also volunteered to make signs about Spa hours and non-allowance of glass materials to post in the Spa. The Board approved up to \$25 for the signs.
- **d.** Two of the decorative lights in front of the 5924 building were not working and two downstairs walkway lights needed new bulbs. Barbara Harshaw will look into ensuring all common area lights are in working order.
