#### A message from our president:

#### Hello NRE Neighbors!

This is my last column as your President and I want to say that I have enjoyed serving you and the HOA. I have met more of my neighbors during these five years and made many more friends. We have accomplished a lot together and have helped the community build positive relationships. Now it is time to just be a friendly neighbor and continue to help by volunteering as the Good Samaritan.

There are two things that I wanted to accomplish before leaving my office. One was completed and that was to drop the speed limit on Ascot Drive from 40 mph to 30 mph. The other was to lower the property tax on all properties (other than 10-acre lots which was performed some years ago). Everyone's land tax is different and it is an injustice. I recently mailed a letter and met with the tax appraiser to make this a formal complaint. I will follow through with this and inform you of the outcome.

If you've been getting the emails, you already know that NRE has experienced many incidents of suspicious activity and a suspected attempted home invasion. Please be alert and have a plan to protect yourself in case this occurs at your home. Call 911 with ANY suspicious activity you witness in our neighborhood. Then call Kurt to send one of our C.O.P. volunteers to that area. I recommend taking Sether's class listed in the classified section to help you feel comfortable with a firearm and in protecting yourself. Sheriff Bob Alford's emailed response to me stated that it could take up to 30 minutes for a Deputy to arrive in our neighborhood after 911 is called. I have requested increased patrols because of the reported incidents but it still relies on your protecting yourself.

#### \*\*Deed Restriction Change Discussion

Multiple variances to the 25' easement have been granted by the community to owners of 1 ½ acre lots. Many HOA members have said that the easement should be lowered for smaller lots because a 25' easement is not reasonable for that size lot.

This possible change to the Covenants and Deed Restrictions (CCR) will be discussed during the January 7<sup>th</sup> Association Meeting. This proposal would add the highlighted area below to the applicable paragraph as follows:

7. No buildings or structure of any kind shall be located on any lot near to the front, side, or back lot lines less than twenty-five (25) feet on lots greater than 2-acres and 15' on lots less than 2acres; provided, such setback may be waived by NOLAN RIVER ESTATES **HOME/PROPERTY OWNERS** ASSOCIATION, INC. as to the individual lots where deemed by NOLAN RIVER **ESTATES HOME/PROPERTY OWNERS** ASSOCIATION, INC. appropriate because of terrain of such lot. For the purpose of this covenant, eaves, steps and open porches shall be considered as part of a building. Lots shall "front" on the adjoining public way; corner lots shall be deemed to "front" on the way adjoining the shortest lot line, however, the driveway to that family dwelling may be via any adjoining public way.

#### \*\*Possible Increase in Annual Dues

Annual dues have been \$41 or less per year since 1998. Possible uses of the increase were discussed at the October Association meeting and are included in those minutes. It will be discussed again at the January Association meeting and voted on at that time.

#### **Crime Watch**

#### Possible Attempted Home Invasion -

On Sunday evening, 29 November, in the 4700 block of S. Nolan River Rd., two individuals were standing in the pasture after dark. They took off running when they were observed. While the owners called 911, there was banging on the outside of the house. The responding deputies did not find anything. Prank or not, who knows, but either way this could have ended in disaster.

Suspicious Activity – In daylight, on a day during the first week of December, someone was tapping on windows on different sides of a home in the 4400 block of CR1219. It lasted only about 5 minutes and no car was seen in the driveway. The owner believes that the barking from their dogs may have scared away whoever it was.

Suspicious Activity – Around midnight of 6/7 December a different owner in the 4400 block of CR1219, heard unusual noise outside their home and they turned on lights. The suspicious noise stopped and shortly after that a duck call was repeated three times, as if a signal. The noise did not return.

Home Being Cased – On 9 November, as a resident was arriving home about 7 pm in the 4400 block of Ascot, a silver or light blue van pulled up to their house and turned off their lights. They shined two small red lights on the house. They finally drove away when they saw the homeowner on the phone. The incident was reported to the S.O.

Suspicious Vehicle – About 7 a.m. on 4 November a grey truck sat in front of the closed gate of a residence in the 4200 block of Saint Leger for about 25 minutes. It eventually left.

Suspicious Vehicle – In the 5000 block of Saint Leger, on Wednesday morning (16 Dec), a silver Toyota Tundra drove up a driveway, turned around, sat for a bit (out of sight from the street) and then drove back down the driveway, sat at the end of the driveway for a bit and then drove off.

It was either this same vehicle (silver Toyota Tundra) or a very similar one that has been seen cruising Preakness and CR 1210. The driver was either a white or Hispanic male, sometimes with its driver's window down.

These incidents are disturbing and everyone needs to stay vigilant. Jon Puryear, our HOA president, requested more patrols by the Sheriff's Office and they said they would do their best.



Sign Stolen - Another Do-Not-Litter sign has been stolen. This makes the third time this sign has been stolen this year. Cost of the sign is close to \$200 and has not yet been replaced. The now empty pole is located on the west end of NR.



Sign Knocked Over – The curve sign in front of 4849 Saint Leger was found on the ground. It was reported to the Precinct Thursday, 17 December and they had it back in place on the same day.

Anyone having information about a crime or suspicious activity is encouraged to call the Sheriff's office at 817-556-6060 or Crime Stoppers.

Good Afternoon My Friends,

It has been quite some time since you have received any information on the ongoing saga of TAMER/Monarch/PUC/OPUC. Consequently, as we approach Thanksgiving and the Christmas holidays I thought it would be good to tell you where the TAMER and Monarch situation stands.

- A. The first of the 3 attachments is there for its smile value. The next two are letters to the PUC that our attorney David Frederick sent on our behalf during the rules making process. Since that time things have been very quiet.
- B. Several have asked where we stand on the upcoming potential for a rate case filing by Monarch after the 1st of the year. To date we have not had any indication of if or when Monarch might file for a rate increase. However, I would remind you that Monarch can no longer simply send you, the ratepayer, a letter and then raise the rates 30 days later and we then have to protest. Under the new rules they(Monarch) will file with the PUC and all (ratepayers) will be notified. If there is no protest they then will get the increase. If there is a protest then the case will probably not last longer than 185 days, plus OPUC's legal staff will be helping us along with David. This should mean that it will not be an extended period that we have to raise funds.
- C. <u>T.A.M.E.R.'s FUTURE</u> I want to cover this in separate parts:
- 1. The present TAMER Board consists of 11 persons. However, I have sent out 3 different e-mails to the board in recent weeks and only 4 have responded. Let me outline the problem as I see it without volunteers from the overall TAMER group we are doomed to close things down and this must be done before the next rate case. Three of our board members C. A. Cockrell, Jay Wiesner & Chris Jackson are having health problems and need to step away. C. A. & Jay, like myself, have been doing this since 1998. A few of our board members are not even responding to my e-mails, therefore I do not know what their problems may be. In the very near future I will be resigning, since I think 17 years is long enough.
- 2. Our website has not been updated in a very long time and no one has volunteered to help Chris Jackson to bring it up to date. Someone with computer knowledge needs to step and take over for Chris. Just so you know he designed and financed the Website. Without assistance this to will go away.
- 3. Where are we financially As of today we have \$5,797.84 in the bank and no debts. There have been a several donations this year, but nowhere near enough to carry us through another rate case.
- 4. Without immediate help from you all I plan to do the following:
- a. Before January 1, 2016 I will box up all files and records that I presently have and deliver them to the office of David Frederick in Austin. In that manner all of the records will be preserved and if someone is willing to step up in the future to fight the rate battles David's firm will have all the data. This will include giving him the check book. Presently the 3 authorized signers for checks are C. A. Cockrell, Jay Wiesner and myself. The bank account is in Chandler, Texas. Our mailing address is also a P. O. Box in Chandler. A new board will need to become signator's and probably move the account.
- b. Since we are a non-profit corporation I am sure David's firm will do the necessary filing with the State of Texas in 2016, as they have in the past. Beyond that point the Corporation, without a new board will of necessity go dormant.

<u>IN SUMMARY</u> - While I hate to be the bearer of bad tidings at this Thanksgiving time it is necessary. It has, for the most part, been a pleasure to work with all of you throughout this long uphill battle against the IOU's, Monarch/SWWC, in particular.

I await your responses.
