Move-ups: The deadline to send in your move-up is Monday, Oct 2, 2017 at 6:00 pm. Move-ups must be submitted in writing (email ok).

Height Cards/Measuring: We will have a VMO available for measuring. All dogs without height cards will have to be measured, including 24" and 26" dogs. We will have a measuring official available to measure dogs from 8:00 am to 8:30 am and various times throughout the day.

Start Time & Running Order: Check in and measuring time will begin at 8:00 am on both days, with first dog on the line at 9:00 am. This will be a 2 ring, 2 judge trial. The class running order will be as follows:

Crating: There will be crating space inside the stall area. You may need to share your stall with others as space is somewhat limited. You may arrive for crating set-up after 4:00 pm Friday.

Directions to Fun Fur Paws (22352 Stargate Place, Mt. Vernon, WA 98274):

From I-5 NORTH or SOUTH:

- Take Exit #218 to Starbird Road.
- Go east on Starbird Rd to the 4-way stop at Bulson Rd
- Turn left onto Bulson Rd
- At the intersection with Tye Rd, turn left to remain on Bulson Rd
- Turn right onto Stargate Place, at the Sign for Fun Fur Paws
- Follow Stargate Place to the arena and parking area

B MATCH: We're having a B Match on Friday afternoon one half hour following the last class of the day. \$5 per run. Toys are ok but no food in the rings. Get some extra ring time on your dogs! Dogs do not need to be entered in the regular trials. Dogs may be entered multiple times in the same class with a maximum of 4 runs per dog.
