BUILDING DEPARTMENT REPORT: There were 13 permits issued for the month of April there were 5 building permits, (1 new house) 4 electrical, 4 mechanical and 0 plumbing, for a total fee of \$2036.00.

OLD BUSINESS: Fire charge ordinance was tabled last month. **MOTION BY** Trustee Henderson, **SUPPORTED BY** Treasurer Meyer to adopt amendments to the Fire Charge ordinance #63-A **MOTION CARRIED.**

NEW BUSINESS:

BLIGHT: There were 3 complaints, 1 on Dixon Rd, 1 on Ida-Maybe Rd , 1 on N Custer, all were general blight and junk, and they were all sent a notice. Jim Baldwin was present and asked the Board to give him some more time to remove his cars. The Township Board told him to give us a report at the June 5th board meeting if not before.

MOTION BY Trustee Woelmer, **SUPPORTED BY** Trustee Henderson, to approve the amendments to zoning ordinance 61-N Articles 2,3,9,14 and 17. **MOTION CARRIED.**

MOTIOB BY Trustee Woelmer **SUPPORTED BY** Clerk Fetterly to approve Site Plan and Special Use for Rocky and Megan May of 8649 Eggert rd. Ida, Mi parcel number 5813 226 102 51 to construct a pond (ATF) and to waive the fencing requirements. **MOTION CARRIED.** All conditions were met that were set by planning commission.

MOTION BY Trustee Henderson **SUPPORTED BY** Treasurer Meyer to approve the MCRC contract for Frary Lane. **MOTION CARRIED.**

PLANNING COMMISSION: Trustee Woelmer stated that at the April 16th meeting there was a public hearing on C-3 Ordinance clarifications and a number of different ordinances. Also there was Public hearing for Rocky May for a pond approval. The board and Planner also had discussion on Agri Tourism. The next meeting will be May 21st ,2018 at 7:00 pm.

LMR: Trustee Henderson stated that the next meeting will be May 21st 7:00 pm there will be the election of officers at that meeting Public is welcome.

CITIZEN COMMENT TIME: Mary Jolley of Sheick Rd was inquiring about the potential ball field/complex, they questioned if the Township has received an application yet, and we have not. Mr. Busanbark of Gruber Rd asked questions about the LMR fire charge ordinance.

BOARD COMMENT TIME: Supervisor Blanchette reported that Cherry rd. got paved and the City of Monroe increased their water fee by 10%. Trustee Henderson stated that clean-up day was a success and thanked everyone involved for their help. The Township Board also agreed at this time to keep the clean-up day the last Saturday in April due to Stevens Disposals request.
