## BILLING \& PAYMENTS

If you are behind on your assessments, we urge you to call and establish a payment plan. Payment plans can be set up for a one-time admin fee of $\$ 10.00$. This covers the costs of payment envelopes, postage, and reproduction fees. If your account is turned over to the attorney's office for collections, you will be billed for legal fees which start at $\$ 175.00$. ## POOL TAGS

Pool tags WILL NOT be updated automatically this year. All homeowners will need to obtain new pool tags. Please bring a current photo of each member of your household. These pictures will be kept. If you are a renter, you must bring a copy of your lease agreement or a current electric bill showing your name and property address. You must also provide your landlord's name and phone number.

If you do not obtain your tags on one of the dates listed below, you will be charged an appointment fee of $\$ 10.00$ to obtain your tags.

No pool tag appointments will be scheduled after June $30^{\text {th }}$, unless you are a new homeowner.

Pool tags will be issued free at the clubhouse on Breda Drive on the following dates from 10:00 a.m. - 2:00 p.m.:

In order to use the pool and other common areas, all assessments must be current. Accounts will be verified while updating pool tags to verify up to date assessments. Payments will be accepted while updating pool tags. All payments must be in the form of a check or money order.

## POOL RENTAL

If you are interested in booking a pool party, you can make your reservation by calling the office at (281) 5734027.

- Pool: \$75.00/4 Hours
- Lifeguard Fee: $\$ 20.00 /$ hour
- Deposit $\$ 100.00$ (returned upon inspection)

The above rates are for parties with up to 25 people. You must count all patrons in pool area whether they will be swimming or not. The lifeguard fee covers 1 lifeguard for your party during open hours. An additional lifeguard is required for each additional 25 people @ a rate of $\$ 20.00$ per hour. Night parties over 25 require 3 lifeguards.

## Pool Hours

The pool will open in May for weekends only until May $20^{\text {th }}$, then the pool will be open Tuesday Sunday from Noon to 8:00 p.m. Pool tags must be current to gain access to the pool.

## Safe Routes to School Survey

We have been contacted by Harris County Public Health with the following information:
We are working on implementing a program called Safe Routes to School in Baytown in which we are partnering with the city of Baytown, MD
Anderson, and GCCISD to provide
recommendations and engagement opportunities with a mission to make it safer for children to be able to walk and bike to school if they so wish.
One of the schools we are working with is Banuelos, and this neighborhood falls into their school zone, however, there is no connection from the neighborhood to the school. There is a large ditch and power lines that are a barrier to being able to walk from the neighborhood to the school.

## Heavy Trash Pickup Restrictions

Heavy trash pickup includes washers, dryers, televisions, water heaters, furniture, etc. These items will be collected at the curb. Hotchkiss will also pick up freezers, refrigerators, and other items provided that all CFC's have properly been removed and tagged as such, in compliance with state and federal laws. Items not in compliance with the foregoing will NOT be picked up.

Tree trimmings and branches cut in lengths not to exceed three (3) feet, securely tied in bundles and weighing not more than fifty (50) pounds, will be collected by Hotchkiss.

## HOTCHKISS WILL NOT PICK UP THE FOLLOWING:

Hotchkiss will not pick up scrap materials from construction, repair and remodeling of buildings, concrete, bricks, batteries, tires, tree stumps, or limbs bigger than five (5) inches in diameter and longer than three (3) feet in length, automobile bodies or larger machine parts, hazardous waste, materials of an explosive nature and any other waste which Hotchkiss reasonably believes to be outside the scope of contract.
