## **Membership Information (per GLKDA Bylaws)**

### Article II Membership

Section 1. Shall be open to any individual or firm interested in the drying, storage, and handling of lumber or wood products.

Section 2. Members may invite to meetings any person interested in the purpose of this Association.

Section 3. Membership shall consist of duly qualified members in classifications as follows with rights and privileges as indicated:

a) Company/Organization Membership

- i. Allows up to three (3) named individuals at a single location (address) to receive association mailings.
- ii. Permits one vote per company/organization.

b) Individual Membership

- i. For federal and state employees and individuals who are not employed full time but are interested in staying abreast of kiln drying methods and technology.
- ii. Permits one vote per individual member.

c) Honorary Lifetime Membership

- i. Individual lifetime membership conferred for long and faithful service to the organization (e.g. long term record of meeting attendance, serving as an officer for an extended period, presenter of numerous technical presentations over a long period of time.)
- ii. Nominations for honorary lifetime membership can be made by any member.
- iii. The Board of Directors will vote on all nominations and confer honorary membership upon approval by a simple majority.
- iv. Dues are waived for the life of the honorary member.
- v. Honorary lifetime members will receive all mailings and full membership privileges including the right to one vote.

d) Supporting Membership

- i. Companies or organizations contributing substantially to support activities of the Great Lakes Kiln Drying Association.
- ii. Allows up to ten (10) individuals to receive associations mailings.
- iii. Supporting members are given recognition in connection with association meetings and/or mailings.
- iv. A supporting member is entitled to one vote per company/organization.
