#### **Camp Luther**

Mr. Selmeyer referred the Board to Attachment E and shared a few highlights from the report.

Rev. Roser stated that as the Committee continues to review the Management Agreement, it would be good for the Board to make a decision now on the dollar amount for District support.

After discussion, a **motion** was made and seconded to approve to include, in the newly revised Management Agreement for 2018, a District contribution of \$100,000 annually over the next 5 years in support of the ministry of Camp Luther.

APPROVED.

#### **Unaudited December 2016 Financials**

The financials were presented and discussed. A **motion** was made and seconded to approve the unaudited December 2016 financials as presented. **APPROVED.** 

### **Constitution & Bylaws**

Secretary Thews presented the following Constitution & Bylaw changes for ratification:

A **motion** was made and seconded to approve the above Constitution & Bylaw changes as presented. **APPROVED.** 

#### **District Pastors' Wives Retreat**

A question was asked concerning whether the North Wisconsin District Pastors' Wives Retreat is sponsored by the District and if the District has any oversight over this event. President Lueck shared that this is not a District-sponsored event and that this group has their own Federal ID number and checking account.

To clarify that this is not a "District" sponsored event, it was suggested that a clause be placed on all communication for this event stating "This is not a North Wisconsin District sponsored event." to avoid any confusion and to ensure that interested attendees contact the proper individuals in charge of this group.

# **Spring Pastors' Conference**

Per a discussion held at the November 10, 2016 Board of Directors meeting concerning the belief that the Pastors' Conference was a "District" event, the below motion was approved.

A **motion** was made and seconded stating that beginning in 2017, revenues from the Fall and Spring Pastors' Conferences will come to the District and all expenses will be paid from this account. Existing balances in the pastors' checking account will be transferred to this designated District account.

After further research, it was discovered that the Pastors' Conference also has their own Federal ID number and checking account from which they do business.

A **motion** was made and seconded to rescind the above-stated motion from the November 10, 2016 meeting. **APPROVED.** 

#### **Standing Committee Updates**

### Administrative Services Committee

Rev. William Plautz shared that there is no new business to report.

#### Audit & Investment Management Committee

Mr. Bruce Plautz shared that the accounts are moving in the right direction. Show an \$85,000 increase in one year and were able to provide scholarships in the amount of \$67,400. He believes we are headed in a positive direction; things are growing.

#### **Governance Committee**

Rev. Roser shared that although the Board spent much time discussing and reviewing the new outcomes, they were never approved.

A **motion** was made and seconded to approve the Outcomes as shown in the Strategic Plan that was last Revised/Board Reviewed November 2016. **APPROVED.** 

### Stewardship Committee

Mr. Johnson shared that he and Revs. Shoup & Errer are getting closer to being able to share something on the District website that will be useful to congregations. Stay tuned.

#### **District Designated Funds**

After a discussion on where to designate \$115,000 of District designated funds, a **motion** was made and seconded to approve the below designations.
