Miss Bonnie is a Sugar Mill legend having served as a crossing guard for 17 years. Her commitment is not just to the students -she will also stop traffic for non-students wanting to cross the street. She greets students each morning with smiles and hugs, she knows their names, and she asks about how they are doing.

Ms. Lisa has been a Crossing Guard for 14 years. She always has a smile and a wave, and she exemplifies the type of person that you are happy to know is contributing to your child's safety. She truly cares about their wellbeing, she knows each of them, and she is proud of them all.

Mr. Fred is the newest recruit - only 2 years on the job after serving Fort Bend ISD for 39 years. We're happy he has joined the team. As long as there is a child needing to cross the street, his affable, easy-going smile will be there for them.

A huge Thank you to our Crossing Guards - you are our Super Heroes, not just during the Bournewood construction, but every school day!

Watch out for School Buses! Did you know that passing a school bus that is loading or unloading children is illegal? Here in Sugar Mill, we see lots of cars that violate this law and it endangers our precious children! The law states that even if you are on the opposite side of the road, driving in the opposite direction, you may not pass the bus unless the road is divided by a median, the bus has begun moving again, they have removed their little Stop Sign or turned off their flashing red lights, or unless the driver has waived you on. Hefty fines of up to $\$ 1,000$ for violators! Here are several safety measures drivers can take to help keep children safer:

- When driving in school zones, be alert and watch out for children.
- Slow down and watch for children gathering near bus stops.

- Look for children who might dart into the street without looking for traffic.
- Know and obey the laws concerning school zones and school buses.

Does your car block the sidewalk?? If so, this is in violation of the City of Sugar Land ordinances, and it is a ticketable offense! Please be considerate and leave the sidewalks clear for children riding their bikes, people walking their dogs, and especially moms with strollers. It is unsafe and inconvenient for people to be forced to walk into the street to go around your vehicle!

Noise nuisances, such as a barking dog or people being loud after 10 pm or before 7 am , should be reported to the non-emergency police number at (281) 275-2020, and not Terri Salter (MASC Austin Properties). Terri is not typically able to respond to a situation immediately, and if she, or a representative, cannot see/hear the violation, they cannot take appropriate action to remedy the situation. The police will typically respond within 15 minutes. For those of you who do not want your name to be known, just tell them you prefer not to have your name revealed, and they will respect your privacy. Please note that dogs are not permitted to bark excessively, even during the day. The City of Sugar Land Quiet Zone Ordinance is in effect 7 days a week from 10pm-7am. Please be respectful of your neighbors and do not create noise during that time period.

Don't throw out that towel! Did you know that Sugar Land Animal Services shelter needs your old towels and washcloths to help them clean cages and bathe animals? They are also very appreciative of any kennels, dog or cat beds, and cat litterboxes! They are located on Gillingham, just north of the railroad crossing.


Garage Sales are never permitted within Sugar Mill. Nextdoor.com is a great resource for selling unwanted items. If you decide to post something on Craig's List, please be cautious and meet the prospective buyer in the parking lot in front of the Police Department to add an extra layer of safety to the transaction.

Curb numbering -in mid-April, the house numbers on all curbs will be repainted. If you have a special logo curb address and you want us to paint over it, please email Terri Salter @ tsalter@mascapi.com. Otherwise, all curbs with special logos will not be painted over. If you have a vehicle blocking the curb on the day of painting, they will make a 2 nd attempt on another day.

Squashing some rumors - There is absolutely no truth to the rumor that MASC Austin Properties, Inc. is paid per violation letter they send to owners/residents. They are paid a flat, monthly fee, regardless of how many letters are sent. They do charge the Association for the certified demand letters that are required by the Texas Property Code prior to the HOA performing self-help (for example, we mow someone's lawn) and/or when filing legal action against an owner. The deed restriction reports are closely monitored by the Architectural Control Committee and the Board of Directors. Please correct any violations in a timely fashion and contact MASC Austin Properties, Inc. to address any concerns.

Safety Alert! Now that winter is almost over, many residents are looking to upgrade their homes. Whether it be a new pool, new counter tops, new French doors, or an amazing home theatre system that helps you forget the upcoming summer heat . . . . . whatever you are improving, adding, or installing, there is a good chance you will be hiring some contractors for assistance. Over the last year, there have been reported incidents of crimes committed by private/independent contractors. The Better Business Bureau stated that hiring a house cleaner, worker, or contractor that is licensed, bonded and insured, is 'crucial'. You need to verify that the information they provide you is legitimate and current. Here is a link from the Federal Trade Commission that is very useful when hiring a contractor to work at your residence. https://www.consumer.ft.gov/articles/0242-hiring-contractor. If you have to provide a contractor with a key to your home, change the locks after the job is done. Do your homework and hire responsibly!

Tennis Court Passcodes: If you plan to use the tennis courts, please visit the Sugar Mill HOA website at www.sugarmillhoa.net, click on Documents, and then Tennis Courts. After reading the Tennis Court Rules, and signing and forwarding the document to MASC Austin Properties, you will be emailed the 4-digit passcode. You may not share the passcode with anyone not residing at your home.

Hands-free Cell Phone Law: Sugar Land's new ordinance took effect on March 20th, and prohibits the use of portable electronic devices while driving a vehicle in Sugar Land unless the device is in hands-free mode or being used for an emergency. Drivers will only be issued warnings during the first 90 days; however, following the grace period, any person found guilty of violating the ordinance will be fined up to $\$ 500$ for each offense. Ouch!!

## Marion's Fishing Corner

The Sugar Mill Board of Directors and the Lake Committee are strongly considering adding several man-made "fish structures" to
Misty Lake. With this in mind, I'd like to revisit an article from some years ago entitled IMPROVING FISH HABITAT:

Recently, the Lake Committee embarked upon a fish habitat improvement program. It has become obvious that we will never have any kind of aquatic vegetation growth in Misty Lake. With the bottom of the lake being relatively featureless and flat, our fish have few places to hide and/or ambush baitfish. Nor do the newly spawned fry have a secure place to conceal themselves until they have grown enough to fend for themselves.Most of the fingerling bass are then eaten by larger fish, resulting in a considerably less successful spawn. With this in mind, we decided that it was time to add some kind of "structures" to the lake floor in order to provide some cover for our fish.

In recent years, several members of the committee have gotten together on a Saturday to assemble and place structures in strategic areas of the lake. These structures have consisted of discarded Christmas trees, recycled automobile tires, and plastic PVC pipe. After these structures have been submerged for a while, algae grows on it's surfaces and attracts small baitfish. This in turn attracts larger fish that complete the food chain. Fish of all sizes in our lake benefit from these structures.

Our fish habitat improvement program continues on, so we will be adding to the structures in the future. The more places that we have for our fish to seek sanctuary, the better. With the total absence of any type of weed growth in the lake, the addition of these man-made structures can only help improve the condition and overall health of our fish population. Hopefully this explains the importance of the new structures that are being proposed.
