Dear Marathon Parents and Community Members,

We were advised on Wednesday, September 8, 2021, that two people at Appleby and one person at the Junior/Senior High school have tested positive for the COVID-19 virus. The Cortland County Health Department will be initiating an investigation and will start the contact tracing process. Today, Marathon staff are reaching out to families of students that may have been in contact with the individuals who have tested positive for COVID 19. All affected staff have been contacted. Health Department personnel will officially reach out to anyone who has had close contact with the positive individuals and provide quarantine guidelines. If an unknown number calls your phone in the next few days, please answer as this may be a call from a NY State contact tracer. All staff members who were directly exposed will either be quarantined for the next 10 days (and can return to work after those 10 days if they have no symptoms) or will remain working but have their vaccination status confirmed by DOH. All students who were directly exposed will be quarantined with those same parameters.

The people who tested positive, and any other students/faculty/staff who were exposed and have not been vaccinated, will not return to school until the Cortland County Health Department provides clearance for them to do so. Students and staff who are vaccinated can return to school as long as they are symptom-free. Vaccinated persons will be contacted by public health to confirm vaccination status and be given the most up to date CDC recommendations for continued well being. We hope you understand that we cannot provide any additional information about the people who tested positive due to confidentiality concerns. We will continue to clean and sanitize our school buildings and school buses on a daily basis.

Please continue to practice and encourage good hand-washing hygiene, wear face masks, and practice social distancing. If you start to exhibit symptoms of COVID-19 (defined by CDC to include fever, cough, shortness of breath or difficulty breathing, chills, muscle pain or body aches, headache, sore throat, new loss of taste or smell, fatigue, diarrhea, nausea or vomiting, congestion or running nose), please reach out to your physician and inform the appropriate school principal.
