## **Local COVID-19 Testing Site**


Compass Health Drive Thru Testing Tent (19515 Brune Pkwy, Warrenton MO 63383) MUST call first 636-377-2434. NO out-of pocket cost, you do NOT have to be a Compass health patient and you do NOT have to be a Warren County resident. If you are a close contact to a positive case or someone who is being test for COVID-19- you can get tested without symptoms, If you have one of the COVID-19 symptoms or you have a symptom the screening determines is relevant, you can be tested. You do NOT have to have a fever or cough to get tested-COVID-19 symptoms include: fever, feeling feverish, chills, cough, shortness of breath or difficulty breathing, repeated shaking with chills, muscles aches, headache, diarrhea, new loss of taste or smell or any symptom a medical provider feels is relevant.

## Warren County Health Department COVID-19 Update

As of June 8, 2020 at 1:04pm, there are 35 positive <u>lab confirmed</u> cases, and 28 have recovered in Warren County. 16 of those reported cases are in the 63390 (Wright City/Innsbrook) zip code.

This case count data includes **only** LAB CONFIRMED cases and there are others out there. You should take the precautions that we have been advising seriously and follow them, regardless of the number of cases in your hometown. Wear a mask in public when you around others, practice social distancing and stay at least 6 feet apart, wash your hands and surfaces frequently and avoid touching your face.
