Civic Report

Update on housing developments around Fiesta Gardens:

In addition to 599 units at Station Green, a pre-application for 64 units at the AAA building on Delaware, and the continued expansion of Bay Meadows, we now hear that CalTrain has plans to build housing units on half its car park at the Hayward Park station (behind the Station Park development). In addition, a developer is looking to develop the Rite Aid site with housing and retail. It also seems inevitable that the City will develop the corporation yard behind the ARCO station. Judging by the size of these sites, this could be many more hundreds of units. All this without any plans to improve traffic flow through our area. If you think traffic is bad now....

As a community, we need to be contacting our City councilors to voice our opposition. We need to ask for a moratorium on further development until the impact of current developments has been assessed. The problems we have now are due to lack of planning by the City to proactively upgrade our infrastructure to deal with the population growth. This is an election year - they will listen.

Traffic Action Plan (TAP)

The TAP for Fiesta Gardens was discussed at the March 8th public works commission meeting. A number of measures were discussed with the goal to improve safety and reduce cut-through traffic through Fiesta Gardens. The funding for all of San Mateo, covering about 19 neighborhoods is \$400,000 per year for two years. This is woefully short of what is needed to address serious needs across the city.

To put this in perspective the City expects to spend \$40 million to build a nice new corporate yard (http://www.cityofsanmateo.org/DocumentCenter/View/39833) at the waste water plant on Detroit Avenue to free the existing site for housing development. One of the commissioners, Laurie Watanuki, asked why some TAP ideas were to widen streets and improve traffic flow when the idea of the Transit Orientated Development (TOD) plan was to get people out of cars. We should be asking how they think they can reduce traffic and get people out of cars when they are building hundreds of new housing units with nearly 2 parking spots per unit. This seems antithetical when the idea of a TOD is for residents to use transit. The opening statement in the TOD plan

(<u>http://www.cityofsanmateo.org/DocumentCenter/View/1782</u>) is to create these developments "while maintaining and improving the quality of life of for those who <u>already live</u> and work in the area." One of the core council priorities is to "Support future growth and redevelopment in Downtown, other commercial areas, and along the transportation corridor to ensure a well-planned environment and promote a high quality of life". One could argue they are not meeting expectations. Let's hold them accountable.

Sewage Tank.

We were informed by the public works department that a contract to put the sewage tank in the events center has been sent to the Events Center Board. We will continue to monitor the progress until the shovels are in the ground and construction begins.


