Kelly has ten years of experience working in the mental health field, focusing primarily on children and families. She completed her undergraduate internship in an inpatient drug rehabilitation program. Her graduate internships were in two residential treatment programs, one of which treated teen males and the second serviced children between the ages of 4 and 8.

After completing graduate school, Kelly obtained her social work license in the state of Maryland and began her career in the Towson area of Baltimore County. She worked for 9 years in a treatment foster care program where she worked with children with separation and adjustment issues, autism, learning and developmental disabilities, and PTSD. She has extensive experience working in the public school system and court system. Kelly completed an Early Childhood Mental Health certification program in 2008. She obtained her clinical license in 2010 and shortly after began providing supervision.

Kelly subscribes to the Code of Ethics of the National Association of Social Workers. Kelly maintains her license by obtaining 40 continuing education training hours biannually. These trainings focus on children, families, evidenced based practices, and diagnosing and assessing.
