4. Listed below are the conditions governing the housing of returnees' wives at an AAF Redistribution Station:

a. The returnee's lawful wife is the only person for whom accommodations can be provided. Children and pets will not be permitted to occupy government quarters.

b. Wives will be required to vacate the government housing provided their husbands are transferred or leave the station for any other reason. In any event, wives may not occupy a room in excess of twenty-one (21) days, except at the discretion of the commanding officer of the station, authority may be given to increase the stay to thirty (30) days.

c. There will be a rental charge of \$1.25 per day for the housing of the returnee's wife plus a service charge to be determined by the commanding officer of each installation. Enlisted men **MUST** be prepared to pay one (1) week in advance for the accommodations provided for their wives upon arrival at the station to which they are assigned.

d. Officers' and enlisted men's wives will be served meals in the respective messes. A separate and additional charge will be made for such meals.
